1 AN ACT making and concerning appropriations for fiscal years ending
2 June 30, 2012, June 30, 2013, June 30, 2014, and June 30, 2015, for
3 state agencies; authorizing certain transfers, imposing certain
4 restrictions and limitations, and directing or authorizing certain
5 receipts, disbursements and acts incidental to the foregoing; amending
6 K.S.A. 2012 Supp. 74-50,107, 74-99b34 and 79-4227 and repealing the
7 existing sections.

9 *Be it enacted by the Legislature of the State of Kansas:*

10 Section 1. (a) For the fiscal years ending June 30, 2012, June 30,
11 2013, June 30, 2014, and June 30, 2015, appropriations are hereby made,
12 restrictions and limitations are hereby imposed, and transfers, capital
13 improvement projects, fees, receipts, disbursements and acts incidental to
14 the foregoing are hereby directed or authorized as provided in this act.

15 (b) The agencies named in the act are hereby authorized to initiate
16 and complete the capital improvement projects specified and authorized by
17 this act or for which appropriations are made by this act, subject to the
18 restrictions and limitations imposed by this act.

19 (c) This act shall not be subject to the provisions of subsection (a) of
20 K.S.A. 75-6702, and amendments thereto.

21 (d) The appropriations made by this act shall not be subject to the
22 provisions of K.S.A. 46-155, and amendments thereto.

17 chapter 175 of the 2012 Session Laws of Kansas or in this act or in any

20 Sec. 50. *Appeals to exceed expenditure limitations.* (a) Upon written
21 application to the governor and approval of the state finance council,
22 expenditures from the special revenue funds may exceed the amounts

25 initiatives fund, the children's initiatives fund, the state water plan fund or
