<u>Hearing on: HB2537 — Kansas expanded lottery act; racetrack gaming.</u>

Chairman Ryckman called the meeting to order and opened the hearing on **HB 2537**.

Mike Heim, Office of the Revisor of Statutes, provided a briefing on the bill (Attachment 1). The bill requires registering agencies to make recommendations to the Kansas Racing and Gaming Commission, for programs benefiting economic development; reduces the number of racing weeks; reallots the distribution of net electronic gaming machine income; reduces the racing application fees for fair associations; changes simulcasting license criteria; amends the state debt set-off statutes; requires a vote in Sedgwick County for placing electronic gaming machines at the Wichita Greyhound Park; and establishes a Kansas horse council fund.

Proponents of the bill responded to questions from

committee members, Dr. Hall stated that the racetracks operations provide for the greatest impact, with revenue streams that flow to the rural counties. The state receives 22 percent from lottery machines, he noted. Discussion continued regarding economic development issues, competition within gaming communities and the Fair Fund.

Christine Dorchak, Grey2K USA, presented testimony as an opponent of the bill (Attachment 6).

Eric Stafford, Kansas Chamber of Commerce, presented testimony as an opponent of the bill (Attachment 7).

John Frieden, Kansas Star Casino, presented testimony as an opponent of the bill (Attachment 8).

Carol Marinovich, Protect the Partnership, presented testimony as a opponent of the bill (Attachment 9)

Whitney Damron, Kansas Entertainment, LLC, presented testimony as a opponent of the bill (Attachment 10).

Opponents of the bill responded to questions from committee members. It was noted that a majority of the revenues are from electronic gaming machines, other expansions in the south central zone would have a detrimental effect. It was noted that approximately 90 percent of the gaming revenue is within a 50 mile radius of the Mulvane, Kansas casino. Discussion followed regarding the impact of the bill as related to contractual provisions, and refunds of all privilege fees for the four gaming facility management contracts. Mr. Sneed stated that Nascar will make the determination on whether there will be a second race scheduled at the Kansas Speedway.

Discussion continued by committee members regarding the impact of the bill, as related to increased employment opportunities with the potential opening of four race tracks, economic impacts within the gaming zones, and potential financial liability for breach of contract, and the hold harmless clause. Additional discussion was held regarding a declaratory judgement from the courts in regards to contractual violations.
