The FY 2014 Approved budget for Problem Gambling Services program also includes the addition of \$138,000, all from the State General Fund, which is not reflected in the expenditures above.

The FY 2015 approved also includes language requiring that no one who seeks treatment for problem gambling be refused treatment and the addition of language transferring up to \$1.0 million from the DADS Social Welfare Fund to the Problem Gambling and Addictions Grant Fund, if needed for FY 2015.
