Presentation on: School District Accreditation

The Chairman invited Brad Neuenswander to address the committee on school district accreditation. Mr. Neuenswander provided a history of school accreditation in Kansas and made clear that accreditation is a state event which is not connected to federal initiatives. The State Board of Education has been working on the development of a new model for accreditation and hopes to approve it in the spring. Mr. Neuenswander answered questions from the committee. Presentation on: Teacher Licensure

Scott Myers presented historical background on teacher licensure in Kansas.
