V. RECOUNT

KS House District 79 (Cowley & Sumner Counties)
Republican Larry Alley requested a hand recount. Results did not change—Democratic incumbent Ed Trimmer won.

VI. MINOR PARTY

Maintaining official recognition as a party requires nomination of a candidate for statewide office and at least one such candidate receiving 1% of the vote. The Libertarian Party retained official recognition.

A party whose candidate for Governor receives 5% of the vote achieves major party status and is authorized to participate in the primary in future elections. The Libertarian Party's candidate for Governor, Keen Umbehr, fell short with 4.0% of the vote.
