## Fiscal Note for House Bill 2543 (Requiring a manual audit of certain election results)

County: Shawnee

Tasks to perform the intended audit would include election board workers & election office staff (machine) sorting ballots and hand tallying the specified ballots. Election office staff would also have some tasks in preparing the necessary documents, machines, supplies and procedures/processes for this audit. The timeframe for completing the audit may require some additional costs for accomplishing these tasks by more people performing the same tasks at the same time. Costs would vary greatly depending upon the selection of precincts or districts/races to be audited. Estimated maximum costs for Shawnee County are shown below.
