Chairman Hedke mentioned the EPA proposed rule associated with the Waters of the US, and that the EPA received a very high volume of comments on this rule, and that it's expansive and quite invasive as far as property rights and other factors relating to it. Chairman Hedke stated that he and Sen Larry Powell issued joint letters to Administrator McCarthy back in the summer with respect to that rule. The EPA has chosen to ignore Federal Regulations governing how they should share proposals in advance of issuing a proposed rule. Multiple entities that should have been contacted at the state or local level, with which to coordinate, were not contacted. The concept of coordination is what is involved and they simply have chosen to ignore it. Chairman Hedke and Senator Powell brought that to their attention, also asking for multiple documents from the EPA. None of these documents have been delivered.

Chairman Hedke noted the EPA's proposed Rule 111(d) is also generating considerable public comments, and that the committee will be dealing with it in the near future.

The next committee meeting will be Friday, January 16.
