# <u>Hearing on: SB175 — Exercise of religious freedom by postsecondary education student associations.</u>

Chairman Brunk opened the hearing on **SB175**. Jason Long, Revisor of Statutes, gave a briefing on the bill. (Attachment 1)

Written testimony in support of **SB175** was presented by:

Senator Steve Fitzgerald who said that the opponents of the bill are not against student groups that define themselves. Rather, it is against religion. They are offended that anyone would practice a religion in the public square. They seek to twist our founding documents to become a guarantee from religion rather than of religion. (Attachment 2)

Gregory Jao said that an increasing number of universities are interpreting otherwise good nondiscrimination policies in ways which prohibit religious groups from using religious criteria in

leadership selection. Religious based criteria help insure that the student group remains faithful to its original religious tradition, purpose and goals even as large numbers of non-adherents participate in the group. (Attachment 3)

Craig Shultz said that pluralism, essential to a free society, prospers only when the First Amendment rights of all Americans are protected regardless of the current popularity of their speech. **SB175** would address the ongoing national problem of some colleges using nondiscrimination policies to exclude religious student groups from campus. (Attachment 4)

Curtis Cole said that this bill affirms the value of a pluralistic view of Religious Liberty. We need to respect other Americans who view the world differently than us. We celebrate the right of the Jew to believe and behave as a Jew. Furthermore, we object when laws are established that preclude the right of Americans to believe and behave with religious conviction. (Attachment 5)

Michael Schuttloffel said that religious groups should be free to require that their members and leaders share in that group's faith. That is the entire point in having such a group. This bill would prevent public universities in Kansas from imposing "all-comers" policies on religious student groups. Universities that institute such policies do so under the guise of nondiscrimination, but in fact use them to target specific religious student groups whose beliefs are not in favor with academic elites, to punish religious students whose beliefs they do not like. (Attachment 6)

Jamie Veeder said that it is essential that religious groups continue to be able to use religious criteria while determining leadership. Without that protection the integrity of religious groups is compromised and the university loses voices. (Attachment 7)

Written testimony in opposition to **SB175** was submitted by:

Micah Kubic who said that this bill is not necessary for the protection of the associational rights of students. Moreover, it will require public universities to provide public funding to discriminatory student organizations in violation of their First Amendment right to academic freedom. (Attachment 8)

Brandi Fisher said that their primary concern was the use of public funds for potentially discriminatory behavior. (Attachment 9)

Jennifer Parson said that the bill would require post-secondary institutions to provide public funding to student organizations which discriminate against women. (Attachment 10)

Jackie Carter said that the First Metropolitan Community Church serves all those in need whether or not they understand or accept those who identify as GLBT. (Attachment 11)

Paul Jackson said that religious beliefs are already powerfully protected in this state and country. This bill seeks to further divide our communities and our public spaces. (Attachment 12)
