


3384 initial and reinstatement applications were submitted in 2015, which is an 16% increase from 2014.

The largest percent increase in applications submitted were for DOs -174 applications in 2015 and 115 in 2014 51% MDs - 896 applications in 2015 and 721 in 2014 24% Postgraduate permits - 343 applications in 2015 and 286 in 2014 20%








KBI/FBI Criminal Background reports for MD, DO, DC initial and reinstatement applications


KBI/FBI turnaround time averaged 8 days 1520 reports were requested
