## MR. CHAIRMAN:

I move to amend HB 2471, on page 6, following line 2, by inserting:

"New Sec. 6. (a) On July 1, 2016, the Kansas board of barbering, provided for by K.S.A. 74-1805a, and amendments thereto, is hereby abolished.

- (b) On July 1, 2016, all of the powers, duties and functions of the Kansas board of barbering are hereby transferred to and conferred and imposed upon the Kansas state board of cosmetology.
- (c) All rules and regulations of the Kansas board of barbering in effect on July 1, 2016, shall continue to be effective and shall be deemed to be the rules and regulations of the Kansas state board of cosmetology until revised, amended, revoked or nullified pursuant to law.
- (d) On and after July 1, 2016, whenever the Kansas board of barbering, or words of like effect, is referred to or designated by a statute, contract or other document, such reference or designation shall be deemed to mean and apply to the Kansas state board of cosmetology.
- (e) On and after July 1, 2016, the balance of funds appropriated and reappropriated to the Kansas board of barbering is hereby transferred to the Kansas state board of cosmetology and shall be used only for the purpose for which the appropriation was originally made.
- (f) On and after July 1, 2016, the liability for all accrued compensation or salaries of board members and employees who, immediately prior to such date, were engaged in the performance of powers, duties or functions of the Kansas board of barbering, or who become part of the Kansas state board of cosmetology, shall be assumed and paid by the Kansas state board of cosmetology.
- (g) On July 1, 2016, the Kansas state board of cosmetology shall succeed to all property, property rights and records of the Kansas board of barbering.

- (h) All employees who were engaged immediately prior to July 1, 2016, in the exercise of the powers or in the performance of duties and functions of the Kansas board of barbering and who, in the opinion of the executive director of the Kansas state board of cosmetology are necessary to the exercise of powers or the performance of duties and functions of the Kansas state board of cosmetology shall remain or become board members or employees of the Kansas state board of cosmetology. Any such employee shall retain all retirement benefits and rights which had accrued to or vested in such board member or employee prior to July 1, 2016, and the service of each such employee shall be deemed to have been continuous.
- (i) No vested right of any person shall be affected and no lawful claim of any person against the state shall abate by reason of the abolition by this act of the Kansas board of barbering. Responsibility for litigation or other reconciliation of such rights and claims is hereby transferred to and imposed upon the Kansas state board of cosmetology.
- (j) No suit, action or other proceeding, judicial or administrative, lawfully commenced, by or against the Kansas board of barbering, or by or against any board member or employee of the Kansas board of barbering in relation to the discharge of duties imposed upon such board member or employee by law, shall abate by reason of the abolition of the Kansas board of barbering. The court may allow any such suit, action or other proceeding to be maintained against the Kansas state board of cosmetology.";
