#### **Bill introductions**

Chairperson Barker then recognized Bill Kerr, Wichita Municipal Court Judge. Judge Kerr gave testimony as a proponent of <u>HB2040</u> (<u>Attachment 1</u>). Questions were directed to Judge Kerr by Representatives Charles Macheers, John Carmichael, and Chairperson Barker.
