Chairperson Barker closed the hearing on <u>HB2330</u> after determining that there were no further conferees to provide testimony.

Hearing on: HB2333 — Cause of action against a person who presents false identification to obtain alcoholic liquor.

Chairperson Barker opened the hearing on <u>HB2333</u>. An overview of the bill was given by Katherine Goyette, Office of Revisor of Statutes.

Chairperson Barker recognized Philip Bradley as a proponent of <u>HB2333</u> on behalf of the Kansas Licensed Beverage Association (<u>Attachment 4</u>). Questions were asked by Representatives Steven Becker and James Todd.

Tuck Duncan provided testimony as a proponent of the bill (Attachment 5). Representative John Whitmer commented favorably on this bill and thanked him for bringing it. Questions were asked by Representative Steven Becker.

Hearing on: HB2112 — Relating to county law libraries.

Chairperson Barker opened the hearing on <u>HB2112.</u> Katherine Goyette, Office of Revisor of Statutes, provided an overview.

Chairperson Barker recognized the Honorable Michael Powers, Chief Judge of the Eighth Judicial District, as a proponent of **HB2112** (Attachment 7).

Charles Rayl also testified in favor of **HB2112** (Attachment 8). Questions were asked by Representatives John Carmichael and Dennis Highberger.

Chairperson Barker noted that there was written proponent testimony from John Purvis (Attachment 9).
