# <u>Hearing on: SB362 — Adding electronically stored information to the criminal justice information system; amending the rules of civil procedure concerning official records and authentication.</u>

Chairperson Barker opened the hearing on <u>SB362</u>. An overview was given by Jason Thompson, Revisor. Questions were asked by Representative John Carmichael.

Brock Abbey testified as a proponent on behalf of the Kansas County and District Attorneys Association (Attachment 2).

Chairperson Barker noted that there was written proponent testimony from Amanda Voth of the Attorney General's Office (Attachment 3) and Ed Klumpp on behalf of the Kansas Association of Chiefs of Police, Kansas Sheriffs Association, and the Kansas Peace Officers Association (Attachment 4).

Chairperson Barker noted that there was written proponent testimony from Dorthy Stucky Halley for the Office of the Attorney General (Attachment 7) and Joyce Grover and Jessica Nasternak on behalf of the Kansas Coalition Against Domestic and Sexual Violence (Attachment 8).

Chairperson Barker recognized Charles Harris, a member of the Family Law Advisory Committee of the Kansas Judicial Council, as an opponent to <u>SB393</u> (<u>Attachment 9</u>). Comments and questions were made by Representatives John Carmichael, John Rubin, Craig McPherson, Leslie Osterman, and John Whitmer.

Eric Commer, District Court Judge of the Eighteenth Judicial District, testified as an opponent of **SB393** (Attachment 10). Questions were asked by Representatives John Carmichael and Kyle Hoffman

Judge Keven O'Grady provided neutral testimony on behalf of the Kansas District Judges Association (Attachment 12).

Ron Nelson of the Kansas Bar Association provided neutral testimony on <u>SB393</u> (<u>Attachment 11</u>). Chairperson Barker inquired as to whether this bill should be sent to the Judicial Council, and Mr. Nelson stated that it should.

Chairperson Barker noted that there was written neutral testimony from Milfred "Bud" Dale, Ph.D.

# <u>Possible action on bills previously heard</u> <u>SB415 - Legislative review of exceptions to disclosure of public records.</u>

<u>Representative John Carmichael moved to have the Committee reconsider its previous action on SB415, as amended, seconded by Representative Jim Ward.</u>

At Chairperson Barker's request, Jenna Seematter, Revisor, provided an overview of the open records exceptions in **SB415** (Attachment 14). Comments were made by Representatives Janice Pauls and Pam Curtis.

The Chairperson called for a vote on the motion for reconsideration, and the motion passed.

Representative John Rubin moved to amend **SB415** by adding a sunset date of July 1, 2021, to each of the exemptions in the bill, seconded by Representative John Whitmer.

Representative Dennis Highberger expressed his opposition to the amendment.

Representative Rubin closed on his motion. A vote was taken, and the amendment to **SB415** was adopted.

Representative John Rubin moved to report **SB415**, as amended, favorably for passage, seconded by Representative Becky Hutchins. Following a vote, **SB415**, as amended, was favorably passed.

# SB255 - Amending court docket fees and charges.

Chairperson Barker stated that a proposed <u>House Substitute for SB255</u> is being handed out (<u>Attachment 15</u>). This substitute is a fix to the judicial budget reverting everything back to the statute that was in effect prior to the Supreme Court's decision in <u>Solomon</u>, finding a portion of 2014 **Senate Sub. for House Bill 2338** unconstitutional and striking **HB2338** in its entirety due to the operation of the nonseverability clause. This will help the Supreme Court retain the fees that were in the original bill. Without it, they could lose a considerable amount of funding.

Jason Thompson stated that the Committee has been provided with a copy of a memorandum from Jill Wolters, First Assistant Revisor, to the Senate Ways and Means Committee which sets out everything that was in <a href="https://example.com/HB2338">HB2338</a>, and the 2015 bill, <a href="https://example.com/HB2005">HB2005</a> (Attachment 16) to help the Committee understand what has and has not been included in the proposed <a href="https://example.com/HB2555">Hours HB2355</a>. Mr. Thompson has also provided the Committee with a memorandum he prepared that highlights the fee- and fund-related

provisions that need to be addressed in some way (Attachment 17). A question was asked by Representative Jim Ward.

<u>Representative Jim Ward moved to report SB255 favorably for passage, seconded by Representative</u> Blaine Finch.

Representative Jim Ward moved amend SB255 by striking the contents of SB255 and replacing them with the contents of the proposed House Substitute for SB255, seconded by Representative Blaine Finch.

Representative Steve Becker had a question, which was responded to by Chairperson Barker.

Representatives Blaine Finch and Mark Kahrs expressed their support of the amendment.

Representative Ward closed on his motion to amend. A vote was taken, and the amendment was adopted.

<u>Representative Jim Ward moved to report House Substitute for SB255 favorably for passage, seconded by Representative Blaine Finch. Following a vote, House Substitute for SB255 was favorably passed.</u>
