TESTIMONY FOR HOUSE BILL 2024

Good afternoon Chairman Barker and Committee Members:

I brought this issue to the attention of the Judiciary committee late last session. Then Chairman Kinzer gave me the opportunity of a hearing – HB 2712.

Since it was so late, the bill didn't go forward but was recommended to the Judicial Council's Criminal Law Advisory Committee, for consideration regarding effectiveness of the first change. See attached list of committee members.

Originally, HB 2712 was amending the domestic battery statute in two ways.

- a) Mandating a domestic violence offender assessment (which is currently up to the sentencing judge).
- b) Create a new subsection that at the time of sentencing for a conviction of domestic battery, the court (judge) shall consider any current or prior protective orders issued against the offender.

There was in depth conversation regarding the effectiveness of BIP (Battered Intervention Program).

Some of the conclusions were:

- *Committee was unable to draw firm conclusion on the overall effectiveness of BiPs. But there were quite a number of differences of opinion.
- *Offenders pay the cost for the program (26 weeks). It is hard for offenders to pay.
- *Not every county has assessment capabilities available. This provision was removed from consideration going forward.

Hence, Provision (b) is what HB 2024 is all about and will be "beneficial to the process".
