Testimony of the Kansas Association of Criminal Defense Lawyers Neutral

Dear Chairman Barker and Members of the Committee:

The Kansas Association of Criminal Defense Lawyers is a 350+ member organization dedicated to ensuring justice and due process for people accused of crimes and other wrongdoing.

We are very thankful that Representative Gonzalez has introduced this issue to the Legislature. He is a champion for the wrongfully convicted. We are also so grateful that Floyd Bledsoe is spending his valuable time sharing his story with policy makers and the public as a whole. We are honored to be a conferee along side so many wonderful advocates.

One thing we want to specifically address is the bill's failure to compensate those people who plead rather than have a trial.

Last week at the hearing on HB 2593 (recording certain felony interrogations), we learned that 28% of exoneration cases involved false confessions (and 68% of those cases were homicides). According to the Innocence Project, 72% of cases involved eyewitness misidentifications and 47% involved unvalidated/improper forensics.¹

As you know, recently the Legislature made significant changes in the sentences for murder. In 2013, the presumptive sentence for premeditated first degree murder increased from Life/Hard 25 to Life/Hard 50. The sentence for felony murder increased from Life/Hard 20 to Life/Hard 25. Also in 2013, the Legislature created the crime of attempted capital murder, which carries a sentence of Life/Hard 25. The sentence for capital murder when the jury does not impose death is life without the possibility of parole. The presumptive sentence for second degree murder is 147 to 653 months, depending on the defendant's criminal history. The presumptive sentence for first-time Jessica's Law offenses is Life/Hard 25.

Attached is a sentencing grid for drug and nondrug offenses. The presumptive sentence for rape (a SL 1 offense) is 147 to 653 months, depending on criminal history.

In Kansas, an average of 97% of felony cases resulting in a conviction are pleas. Attached is a chart showing the numbers from all 31 judicial districts in Kansas. This data is from the 2015

Annual Report for the Courts of Kansas.² For example, 59 out of 105 counties had zero jury trials in FY 2015.³

How do a 97% average plea rate, Kansas sentencing law, and the reasons for wrongful convictions all relate? It boils down to this: often the risks are too great for people to take their cases to trial. As a result, innocent people plead to things they did not do.

We strongly urge this Committee to amend the bill to allow defendants who entered pleas and who are later exonerated to be eligible for compensation. In addition, we encourage this Committee to recommend an interim study so that the issues raised by the conferees and others can be discussed so that our future law can be the best it can be for those who are wrongfully convicted.
