## **Bill introductions**

Representative Tom Phillips requested a committee bill relating to sewer districts and increasing the construction contract bid threshold. Without objection, the bill will be introduced as a committee bill.

Representative Tom Phillips requested a committee bill relating to location restrictions on microbrewery locations and seeking an exemption in core commercial districts. Without objection, the bill will be introduced as a committee bill.

Representative Virgil Peck requested a committee bill designating Cowley County as the official stone bridge capitol of Kansas. Without objection, the bill will be introduced as a committee bill.

Representative John Whitmer requested a committee bill relating to improvement districts and their procedure for filling vacancies. Without objection, the bill will be introduced as a committee bill.

## HB 2003 - cities; annexation of non-adjoining land.

Chair Huebert called for Final Action on HB 2003.

Representative Houser explained a proposed amendment to <u>HB 2003</u>. The amendment replaces the unanimous vote requirement with a two third's vote requirement. It also would remove all of the language relating to manifest injury to surrounding landowners.

<u>Representative Houser made a motion to amend the bill and submitted the proposed balloon</u> <u>amendment.(Attachment 2) Representative Francis seconded the motion. Motion carried and the bill is favorably amended.</u>

Representative Houser explained a second proposed amendment to <u>HB 2003</u>. The amendment would require that the county commissioner that represents the district or districts in which the land is located vote in favor of the annexation.

<u>Representative Houser made a motion to amend the bill and submitted the second proposed balloon</u> <u>amendment. (Attachment 3) Representative Esau seconded the motion. Voice vote was taken. The Chair was in doubt, therefore a counted vote was taken. Motion failed on a show of hands.</u>

Representative Houser made a motion to pass out HB 2003 favorably as amended. The motion carried.

Scheduled staff presentations were canceled by Chair Huebert since the meeting was not called to order until 2:00 p.m. The pdf file of the staff presentation on abandoned property issues considered by the 2014 Interim Committee was emailed out to committee members and staff. (Attachment 4) Martha Dorsey made a few brief comments to the committee relating to the presentation.
