Honorable Chair Huebert and Members of the Local Government Standing Committee:

At the request of the Finney County Commission, I am writing this testimony to express an opinion about House Bill 2235. This bill has is supported by the county commissioners, but not in its current state. We feel that a change in the population requirement could be made to make the bill more desirable to Kansas overall.

According to this bill, only counties with population of 50,000 or more would have the opportunity to ask voters whether they would support having an appointed County Treasurer versus an elected County Treasurer. It is understandable that some people feel that the larger counties may need a different level of County Treasurer than the smaller counties, but all County Treasurers in Kansas are responsible the collection and distribution of citizens' taxes. Therefore, we feel that allowing all counties regardless of size the opportunity to hold an election to decide on the type of County Treasurer that should be in place is the best alternative.

In addition to our request that the bill allow all counties to vote on the County Treasurer, Finney County would like to see legislation that at least places basic standards that all citizens running for the County Treasurer through an election (if elected and not appointed) must meet.

Some reasons for supporting the bill include the following issues:

- If a County Treasurer does not follow Statutes or misappropriates taxpayer monies, the only way to remove this person is be recall which costs taxpayers more money.
- In this day and age, counties need to be run more like corporations that are trusted with taxpayer funds and faith, which is not always the case as evidenced in Barton County.
- As an elected official, the Treasurer is paid with taxpayer dollars but is not required to show up at the office which leaves management of the department up to non-management level individuals.
- In Finney County, a previous County Treasurer died while in office (1988), which allowed the political party the power to appoint someone that ended up being a non-qualified individual that left everyday around 3 pm for their newspaper route. In addition, this person transferred money between banks making payroll unable to meet their obligations that day since the Treasurer didn't know anything about the bank accounts.

These are just a few of the possible reasons that a county of any size might want to have an appointed Treasurer versus an elected one.
