Chairman Kleeb opened a hearing on HB2377.

Hearing on: HB2377 — Providing for a property tax averaging payment plan and a property tax installment payment plan.

Scott Wells briefed the Committee on **HB2377** by explaining "constitutionality" issues of the bill and each county's option whether or not to participate. He stood for questions.

Senator King presented testimony in support of **HB2377** providing some history and a detailed description of the bill. (Attachment 1) He stood for questions.

Representative Kelly presented testimony in support of **HB2377** by providing additional history concerning the bill. He also gave a detailed explanation of the steps he has taken to offset any "unintended consequences" of the bill. (Attachment 2) He stood for questions.
