Justin exemplified what was right in the United States of America. Justin was among the best and brightest. He gave me hope for the future of our country. I

took comfort in knowing there are other young men, of Justin's caliber, who will lead our Nation in the future. I believe Justin was destined to accomplish great feats in life. Unfortunately, we will never know the full depth and breadth of losing Justin as he is no longer able to accomplish the great things he was destined to accomplish.

Designating a portion of U.S. highway 69 as the 2nd Lieutenant Justin L. Sisson memorial highway is certainly an honor befitting a great man and Justin was a great man. Passing Bill SB5 will benefit future generations because it will encourage them to learn about Justin's story. It will inspire others to live the way he did. It will preserve a reverence for our military and pay tribute to the sacrifices they make. Finally, it will serve as a reminder of the men and women that make the United States of America great.
