HB 2549 - Requests for law enforcement assistance from foreign jurisdictions

Chairman Ostmeyer opened the hearing on **HB 2549**.

Staff provided an overview of the bill.

Representative Willie Dove appeared before the committee as a proponent on the bill. (Attachment 1)

The bill seeks to strengthen the working relationship between the various law enforcement agencies in Kansas and Missouri, so that local law enforcement can request the assistance of officers from other jurisdictions if the need arises without fear of local litigation.

Thomas Hongslo, Police Chief, City of Lenexa, spoke in favor of the bill. (Attachment 2) The bill would allow the Chief Law Enforcement Executive from any law enforcement agency to request assistance from a law enforcement agency of another jurisdiction, including a jurisdiction outside of Kansas.

Ed Klumpp, Kansas Association of Chiefs of Police, Kansas Sheriffs Association, and Kansas Peace Officers Association, testified in favor of the bill. (Attachment 3) Mr. Klumpp states that it is critical in these interstate events that law enforcement officers operating outside their state of jurisdiction be given limited authority, including arrest powers and use of appropriate force. The bill applies the Kansas statutes on arrest and use of force to officers from out of state.

Sheriff Andy Dedeke, Leavenworth County Sheriff, appeared before the committee as a proponent on the bill. (Attachment 4) The bill was originally introduced in 2015, and included just three Kansas counties in the MARC region; the bill has been expanded to include all 105 counties in the state. This change illustrates the desire of Kansas law enforcement to work collectively and collaboratively with their partners to provide the greatest level of public safety available.

Eric Smith, Deputy General Counsel, The League of Kansas Municipalities, testified in favor of the bill. (Attachment 5) The bill would allow law enforcement departments in the state of Kansas to share equipment and personnel in times of critical incidents.
