Staff provided an overview of the bill.

Representative Blake Carpenter appeared before the committee as a proponent on the bill. ([Attachment 1](#)) The bill prohibits a school district from adopting a policy that would prohibit an organization from conducting activities on school property solely because the activities include the possession and use of air guns by participants.

Larry J. Richardson, Derby B-B-gun Club, spoke in favor of the bill. ([Attachment 2](#)) Passage of the bill will allow officially and specifically the use of school facilities throughout Kansas for air gun safety training and practice as a modification of the current statewide guns in schools policy.

methods to achieve them. State intervention should be focused on schools or districts that fail to meet ambitious but reasonable standards.

The bill does not address student educational outcomes, but instead concerns local school board policies regarding school facilities, student activities and district safety and liability. The bill seeks to prohibit local school boards from adopting policies that prohibits an organization from conducting activities on school property solely because such activities include the possession and use of air guns by the participants.

Tom Bruno, representing himself, but serves as At-Large Board of Education Member for Auburn-Washburn, USD #437, spoke as neutral on the bill. ([Attachment 15](#)) The bill, as passed the House, would prevent local districts from determining their own facility usage policies, and that is of concern. USD #437 has facility use policies in place to allow members of the taxpaying public the opportunity to use the facilities they pay for through their tax dollars; at the same time the board has created use policies that are in place to protect the investment taxpayers have made in those same facilities.

As fate would have it, USD #437s Airforce Jr. ROTC program came to the board meeting on March 21, 2016, to request starting an air rifle team. They have a plan to use an older building the district uses for storage and have a secured grant for funding and are doing fundraising to get the necessary supplies for the team. Since that activity is currently allowed under state law, under KSA 72-89a02, Mr. Bruno fully supports the request.

Chairman Ostmeyer closed the hearing on **HB 2468**.
