Joanna,

I received the following fiscal note information from the Secretary of State. Let me know if this information is sufficient or if you would like a more formal fiscal note issued by the Division of the Budget. The Secretary of State estimates that House Concurrent Resolution No. 5008 would require \$29,833.06 from the State General Fund in FY 2017 for state publishing requirements. Additionally, counties would be required to spend a total of \$76,000 for ballot programing costs.

Attached is our spreadsheet we created last year reflecting costs associated with HCR 5008.

A Proviso in the 2014 appropriation bill requires us to “provide a report to the house appropriations committee and the senate ways and means committee detailing the costs of publication in a newspaper in each county pursuant to KSA 64-103, and amendments thereto, of any constitutional amendment that in introduced by the legislature during the 2012 regular session of the legislature.” We will provide an updated spreadsheet to the committees once it is completed.

If an SCR of HCR passes and we have to publish we do request a SGF appropriation in the appropriate fiscal year if a resolution(s) to amend the The text of the constitutional amendment(s) must be published in one newspaper in each county of the state once each week for three consecutive weeks immediately preceding the election.
