Dear Senator King:

I am writing to express my unqualified support of Kathryn Gardner's nomination for the position of Kansas Court of Appeals Judge. I have known Ms. Gardner professionally for almost 30 years, and believe that the nature of my work during most of those years allows me to provide you a unique perspective of Ms. Gardner's strengths and abilities.

I have known Ms. Gardner since 1986, when she became a Law Clerk for the Honorable Sam A. Crow, U.S. District Court Judge for the District of Kansas, when he conducted court in Wichita. At the time, I was an Assistant Federal Public Defender for the District of Kansas, representing indigent clients charged with committing federal crimes. The people I represented were those with no legal or political power whatsoever, who were often incapable of speaking well on their own behalf, and sometimes unsympathetic characters.

It became very apparent to me early in my dealings with Ms. Gardner that she treated all parties and counsel in the cases she worked on with equal respect and professionalism. She was just as courteous to me and my clients as she was to those attorneys and clients possessing the most power and influence. To an attorney in my position, her conduct spoke volumes about her character. I have watched her retain all of those attributes throughout her legal career.
