The presenters made the following points in response to questions and comments from Senators Petersen, Wilborn, Francisco, Lynn and Olson:

- 1.) Investment in rural telecommunications networks provide people opportunities to live, work and thrive in rural areas.
- 2.) Rural telecommunications companies provide good jobs that are vital to the rural economies.
- 3.) Educational institutions such as Fort Hayes State and local community colleges allow rural companies develop the technical expertise to drive high tech rural business.
- 4.) Rural populations and businesses are only being served because of the vital partnerships between local funding and assurances from state and national government (KUSF and USF).
- 5.) Reiterated several times was the statement that the entire state and national networks are more valuable to everyone, if everyone is on the network.

Senator Olson concluded with the observation that because of the universal funds millions of dollars have been invested in rural Kansas networks. He emphasized the importance of modern rural networks to the Kansas economy and the need to continue to closely monitor these processes.
