Dear Senate Utilities Committee:

During the briefing on the Connect America Fund (CAF) on January 14, 2016, members of the Committee requested the Kansas Corporation Commission provide the following:

- 1) a listing of the annual amount of Federal High-Cost Universal Service Funding each carrier receives in Kansas;
- 2) the annual amount Kansans contribute to the Federal Universal Service Fund (FUSF); and
- 3) a larger copy of the map provided on Slide 12 of the CAF presentation.

Attachment A to this letter is a listing of the amount of Federal High-Cost Universal Service Funding each of the carriers received in Kansas, by funding mechanism, for 2014. Calendar year 2014 data is being provided because this is the most current full year of data available. In total, Kansas carriers received approximately \$147 million in Federal High-Cost Universal Service Funding.

Attachment B to this letter is Table 1.9 from the Federal Communications Commission's (FCC) 2015 Universal Service Monitoring Report. The Table illustrates that Kansans contributed approximately \$67.4 million to the FUSF in 2014, which was .85% of the total contributions. Kansas received 2.3% of the total Federal Universal Service funding; therefore, Kansas is a net receiver from the federal Fund. The estimated net benefit Kansas received in 2014 is approximately \$113 million.
