# Hearing on: SB499 — Requiring school districts to strategically source specific spend categories through the department of administration.

The Chairperson opened the hearing on **SB499**.

Tamera Lawrence, Assistant Revisor, Office of Revisor of Statutes, said <u>SB499</u> would require the Secretary of the Department of Administration to contract for the procurement of certain items and services on behalf of school districts (<u>Attachment 1</u>).

Senator Powell asked if a school district had a long-term contract with a vendor, would this bill negate the contract. Ms. Lawrence said the contract currently in place would be negated.

#### **Opponents:**

Leslie Kaufman, President/CEO, Kansas Cooperative Council, noted that the bill would disrupt business and community relationships between local schools and area service providers, and their members (Attachment 2).

Senator Kerschen asked if most school districts own or lease their school buses. Ms. Kaufman said she didn't know the answer to that question.

Thomas Palace, Executive Director, Petroleum Marketers and Convenience Store Association of Kansas, spoke in opposition, and said the bill would harm community and small businesses of Kansas. He noted other negative effects in his testimony. Mr. Palace said a similar pilot program for purchasing fuel was attempted a couple of years ago by the Kansas Department of Transportation that included school districts. Mr. Palace said the major problem with the program was that the school districts do not have underground tanks for fuel storage, and the program was discontinued (Attachment 3.

Darren Muci, Operations Division Director, Wichita Public Schools, appeared before the committee on behalf of USD 229 stating that he recognized the bill is intended as a starting point for discussion on collaboration. However, he opposes the bill due to the complexity, magnitude of implementation and short time frame for start-up (Attachment 4).

Mark Tallman, Associate Executive Director for Advocacy, Kansas Association of School Boards, opposes the bill as it is written, but he views this bill as an opportunity to have an honest conversation concerning the issue of centralized procurement. His testimony included graphs showing per pupil expenditures in several states (Attachment 5).

Senator Powell asked Mr Tallman if he had the total spending per pupil for all states compared to Kansas' rate. Mr. Tallman said he would furnish that information to the committee.
