My name is Susan Lindstrom and I am the Program Coordinator at New Directions Learning Academy in Topeka, Kansas. We are a diploma completion program for adults over 18 whose class has previously graduated without them. We have been in existence for almost 20 years serving students who for various reasons were not successful finishing high school as a traditional student in the 9-12<sup>th</sup> grades. Currently we have a location inside Fairlawn Plaza Mall, and one inside Shawnee County Department of Corrections. Proudly we partner with 8 sponsoring school districts from which our students receive their diploma upon completion of all district requirements.

When our program first began ALL students came to the computer labs to work onsite, which was incredibly difficult for the majority who had job and family responsibilities that took higher priority. Then the opportunity to access classes virtually arose and the interest in our program soared because of the convenience to students not having to drive to a location during our actual hours of operation. The first year we had 3 students work virtually, then in every year that followed those numbers increased by leaps and bounds. Moms could work after kids were tucked in, dads could work after their 3-11 shift. Access is 24/7, 365 days per year. Our students thrived on this option.

New Directions Learning Academy is a program of integrity. This year we had 658 students enroll in both locations. At Fairlawn Plaza we enroll students 1<sup>st</sup> semester August & September, and 2<sup>nd</sup> semester, January & February. Our Shawnee Co. Jail program enrolls students at least weekly, or whenever a new inmate arrives who is interested. As of March 1<sup>st</sup>, we had issued 965 report cards for classes completed and have had 38 students graduate. We are expecting 30 more by the end of the year. Last year we graduated 80 students, many who have gone on to post-secondary education, moved forward in their career choice, or got a decent paying job for the very first time ever! Our community is better off because these students have graduated.

It will be detrimental to our students, our sponsoring school districts, our community and our state if funding is completely gone that allows students the opportunity of accomplishing their goal of graduating and receiving their diploma. These students become taxpayers improving our local economy, while improving their own lives and the lives of their families. Please do NOT take away their opportunity to survive and thrive.

Please do NOT pass HB2403 and SB273; our entire state will lose!

To Whom It May Concern:

My name is Nancy Colón and I'm a retired teacher. I taught math in Wisconsin for 9 years and then moved to Kansas in my 30's and continued to teach math in junior high and high schools in Garden City and Topeka.

In the fall of 1999 I began teaching in New Directions Learning Academy, Topeka, KS. Even though I took a considerable pay cut to make the switch from Seaman High to NDLA, I saw the great benefits of a program to help adults earn a high school diploma even though they had made the mistake of dropping out of high school when they were 16, 17 or 18 years of age. I loved my work at NDLA and even though not all who began our program actually completed it, those who did, made it all worthwhile for me. After teaching at NDLA for 9 years I was asked to be the coordinator of the program which involved 3 schools in Topeka, a job which I kept until my retirement in August 2011.

I remember a young lady who had been a Hayden student, but dropped out to move in with a boyfriend but soon realized that she'd made a huge mistake. We had her transcript reviewed by Topeka High and she took the necessary courses to get a diploma and the very next year she enrolled in Washburn. Another young lady worked for 3 years to complete the necessary coursework and after her graduation, she also entered Washburn with plans of becoming a specialist for diabetic patients, as she'd been the primary caregiver for her own diabetic father as well as raising her own 2 children. She had a supportive husband which was a key component to achieving her goal.

Truthfully, I could go on and on with examples who have appreciated the role of New Directions in changing their lives, helping them achieve a goal that they never dreamed possible after leaving high school, having lacked the maturity of realizing the importance of education for helping to build a life for themselves and their families. It's not only the 18-25 year old students whose lives are changed with the help of NDLA. I remember a lady who was nearly 60 years old when she enrolled in NDLA. She worked in the kitchen at St Francis Hospital; after graduating she received a promotion herself, plus was instrumental in encouraging her grandchildren to enroll in NDLA.

It's conceivable that "some" adult education programs are not benefiting society in a meaningful, life-changing way, but New Directions Learning Academy certainly takes a personal interest in each student and offers each one a unique educational experience. The program needs to continue and the State of Kansas needs to know that the program should continue to be funded for the future of the citizens on Kansas.

To whom it may concern,

I would like to express my concern regarding proposed cuts to the funding for virtual programs for adult students.

I currently work as a teacher at New Directions Learning Academy in Topeka, Kansas. As a teacher, I have observed various students in their educational endeavors. There is nothing more gratifying than seeing an adult student with a diploma in hand!

Our students range in age from 19 to 82. Many of our students have families and full-time jobs. For these non-traditional students, virtual learning is not only a convenience, it is a necessity. Many of our students work on courses after they have finished a long day at work, and/or after they have put their children in bed. Our students often work late into the night, during the time that most traditional schools are closed.

If funding for virtual schools is cut, there is always the chance that adult students could achieve a high school diploma through a GED test. However, many of the students that we encounter lack the basic skills to pass such a test. Many students come to us without any high school credits. Some of these students have a difficult time with fifth grade English and mathematics. Yet these students have the desire to finish their high school requirements. When they do finish, the look of pride on their faces really is something to be seen.

Our particular program has been open nearly twenty years. In that time, we have grown into a very successful program in which students are able to enroll and take classes at no cost. Since 2010, we have issued over 3,500 grade cards for completed classes. We have helped more than 972 students graduate, and we are hoping to hit 1,000 by the end of the current school year. It is anticipated that the number of graduates will compound in the future, as our enrollment continues to increase as word-of-mouth spreads regarding our program.

Our particular program works with eight school districts in the Topeka and surrounding area. These include USD 341, Oskaloosa USD 341, Perry Lecompton USD 343, Seaman USD 345, Silver Lake USD 372, Santa Fe Trail USD 434, Washburn Rural USD 437, Shawnee Heights USD 450, and Topeka Public Schools USD 501. In addition, our service center based in Clearwater, Kansas works with numerous other school districts in Kansas including those in Wichita, El Dorado, and Pratt among others.

Adult education programs for virtual learners are vital to our community and our state. I urge you to reconsider the abrupt cuts that have been proposed. These cuts would be devastating to virtual programs, and they would leave hundreds of students in Topeka with no means to pursue their dreams of completing their high school requirements. If cuts must be made, I would ask that a gradual decrease in funding over several years be considered.

I am writing to urge you to reconsider the cuts that have been proposed for virtual schools for adult education.

I currently work as a special education teacher, and I can tell you that not every student can make it through high school in a traditional timeline. If students want a diploma and are willing to work for it, they should be able to get one. I have known many kids who struggled making good decisions as teens when hormones were wreaking havoc on them. These same kids later became very much positively contributing members of society with good jobs. Their success is largely the result of their ability to complete diplomas later in life after they had matured a bit.

Imagining that every child comes from supportive backgrounds or that all students can complete high school on time is unrealistic. There are many valid extenuating circumstances that may interfere with a student's ability to complete high school by age 18. These are not limited to "poor choices." Medical reasons, family reasons (including the death of a parent), and financial reasons may be factors that cause students to drop out of traditional high schools. Living situations may often force students to choose a job over school. Several of the students that I have come into contact with work full time—even two full time jobs—by the time they are 16. Some families face homeless, and finding a new home becomes their central focus.

If adults decide that they want to obtain a diploma later in life, over time as they work to support their families, the funding should be there to support them in their endeavors.

I urge you not to cut funding to virtual programs for adult education!
