1 AN ACT concerning gaming; dealing with charitable gaming; establishing
2 the Kansas charitable gaming act; dealing with the Kansas lottery;
3 *{dealing with fantasy sports;}* amending K.S.A. 74-8704 and 74-8718
4 and K.S.A. 2014 Supp. 21-6403, 74-8702 and 79-3603 and repealing
5 the existing sections; also repealing K.S.A. 79-4702 and 79-4715 and
6 K.S.A. 2014 Supp. 79-4701, 79-4701a, 79-4703, 79-4704, 79-4705, 79-
7 4705a, 79-4706, 79-4707, 79-4708, 79-4710, 79-4711, 79-4712a, 79-
8 4713, 79-4716, 79-4717, 79-4718 and 79-4719.

10 *Be it enacted by the Legislature of the State of Kansas:*

11 New Section 1. Sections 1 through 18, and amendments thereto, shall
12 be known and may be cited as the Kansas charitable gaming act.

13 New Sec. 2. (a) The legislature hereby declares that charitable
14 gaming conducted by charitable organizations is an important method of
15 raising funds for legitimate charitable purposes and is in the public
16 interest. The purpose of this act is to establish an effective and efficient
17 mechanism for regulating charitable gaming which includes:

- 18 (1) Defining the scope of charitable gaming activities;
19 (2) setting standards for the conduct of charitable gaming which
20 insure honesty and integrity;
21 (3) providing for means of accounting for all moneys generated
22 through the conduct of charitable gaming; and
23 (4) providing suitable penalties for violations of applicable laws and
24 administrative rules and regulations.

25 (b) The intent of this act is to:

- 26 (1) Prevent the commercialization of charitable gaming;
27 (2) prevent participation in charitable gaming by criminal and other
28 undesirable elements; and
29 (3) prevent the diversion of funds from legitimate charitable
30 purposes.

31 (c) In order to carry out the purpose and intent, the provisions of this
32 act and any administrative rules and regulations promulgated in
33 accordance with this act shall be construed in the public interest and
34 strictly enforced.

35 New Sec. 3. As used in this act:

1 (a) "Act" means the Kansas charitable gaming act.

2 (b) "Administrator" means the administrator of charitable gaming
3 designated by the secretary pursuant to section 16, and amendments
4 thereto.

5 (c) "Bingo" or "games of bingo" means the games of call bingo and
6 instant bingo.

7 (d) "Bingo face" or "face" means a piece of paper which is marked
8 off into 25 squares arranged in five horizontal rows of five squares each
9 and five vertical rows of five squares each, with each square being
10 designated by a number, letter or combination of numbers and letters. Only
11 the center square shall be designated with the word "free." No two bingo
12 faces in the same game shall be identical. Faces shall be disposable and
13 shall not be reused after the game in which a player has used such face.

14 (e) "Call bingo" means a game in which: (1) Each player pays a
15 charge; (2) a prize or prizes are awarded to the winner or winners; (3) each
16 player receives one or more cards or faces; and (4) each player covers the
17 squares on each card or face as the operator of such game announces a
18 number, letter or combination of numbers and letters appearing on an
19 object selected by chance, either manually or mechanically from a
20 receptacle in which have been placed objects bearing numbers, letters or
21 combinations of numbers and letters corresponding to the system used for
22 designating the squares. The winner of each game is the player or players
23 first covering properly a predetermined and announced pattern of squares
24 upon the card or face being used by such player or players.

25 "Call bingo" shall include any regular, special, mini and progressive
26 game of bingo.

27 (f) "Charitable gaming" means bingo, including call bingo, and
28 instant bingo and charitable raffles.

29 (g) "Charitable raffle" means a raffle conducted by a nonprofit
30 religious, charitable, fraternal, educational or veterans' organization.

31 (h) "Department" means the department of revenue.

32 (i) "Director" means the director of taxation.

33 (j) "Distributor" means any person or entity that sells or distributes
34 instant bingo tickets, bingo cards or bingo faces.

35 (k) "Electronic gaming device" means a device that, as a result of the
36 insertion of a coin or other object, operates, either completely
37 automatically or with the aid of some physical act by the player, in such a
38 manner that, depending upon elements of chance, it may eject something
39 of value.

40 (l) "Instant bingo" means a game: (1) In which each player pays a
41 charge; (2) in which a prize or prizes are awarded to the winner or
42 winners; (3) in which each player receives one or more disposable pull-tab
43 or break-open tickets which accord a player an opportunity to win

1 something of value by opening or detaching the paper covering from the
2 back of the ticket to reveal a set of numbers, letters, symbols or
3 configurations, or any combination thereof; (4) which is conducted by a
4 licensee under this act; (5) the conduct of which must be in the presence of
5 the players; and (6) which does not utilize any dice, normal playing cards,
6 instant ticket with a removable latex covering or slot machines.

7 Winners of instant bingo shall be determined either: (1) By a
8 combination of letters, numbers or symbols determined and posted prior to
9 the sale of instant bingo tickets; (2) by matching a letter, number or
10 symbol under a tab of an instant bingo ticket with the winning letter,
11 number or symbol in a designated call game of bingo during the same
12 session; or (3) by matching a letter, number or symbol under a tab of an
13 instant bingo ticket with one or more letters, numbers or symbols
14 announced in, or as a continuation of, a designated call game of bingo
15 during the same session.

16 "Instant bingo" shall not include any game utilizing electronically
17 generated or computer-generated tickets.

18 (m) "Lessor" means the owner, co-owner, lessor or sublessor of
19 premises upon which a licensee is permitted to manage, operate or conduct
20 games of bingo.

21 (n) "Licensee" means any nonprofit organization holding a license to
22 manage, operate or conduct games of bingo or charitable raffles pursuant
23 to sections 1 through 18, and amendments thereto. A license shall be
24 required for each affiliated organization of any state or national nonprofit
25 religious, charitable, fraternal, educational or veteran's organization.

26 (o) "Mini bingo" means a game of call bingo in which the prizes
27 awarded are not less than 50% of the gross receipts derived from the sale
28 of cards or faces for participation in the game.

29 (p) "Net proceeds" means the gross receipts received by the licensee
30 from charges imposed on players for participation in games of bingo or
31 raffles and any admission fees or charges less amounts actually paid as
32 prizes in games of bingo or raffles and any tax payable by the licensee.

33 (q) "Nonprofit religious organization" means any organization,
34 church, body of communicants, or group, gathered in common
35 membership for mutual support and edification in piety, worship, and
36 religious observances, or a society of individuals united for religious
37 purposes at a definite place and of which no part of the net earnings inures
38 to the benefit of any private shareholder or individual member of such
39 organization, and which religious organization maintains an established
40 place of worship within this state and has a regular schedule of services or
41 meetings at least on a weekly basis and has been determined by the
42 administrator to be organized and created as a bona fide religious
43 organization and which has been exempted from the payment of federal

1 income taxes as provided by section 501(c)(3) or section 501(d) of the
2 federal internal revenue code of 1986, as amended, or determined to be
3 organized and operated as a bona fide nonprofit religious organization by
4 the administrator.

5 (r) "Nonprofit charitable organization" means any organization which
6 is organized and operated for:

7 (1) The relief of poverty, distress, or other condition of public
8 concern within this state;

9 (2) financially supporting the activities of a charitable organization as
10 defined in paragraph (1); or

11 (3) conferring direct benefits on the community at large; and of which
12 no part of the net earnings inures to the benefit of any private shareholder
13 or individual member of such organization and has been determined by the
14 administrator to be organized and operated as a bona fide charitable
15 organization and which has been exempted from the payment of federal
16 income taxes as provided by sections 501(c)(3), 501(c)(4), 501(c)(5),
17 501(c)(6) and 501(c)(7) of the federal internal revenue code of 1986, as
18 amended, or determined to be organized and operated as a bona fide
19 nonprofit charitable organization by the administrator.

20 (s) "Nonprofit fraternal organization" means any organization within
21 this state which exists for the common benefit, brotherhood, or other
22 interests of its members and is authorized by its written constitution,
23 charter, articles of incorporation or bylaws to engage in a fraternal, civic or
24 service purpose within this state and has been determined by the
25 administrator to be organized and operated as a bona fide fraternal
26 organization and which has been exempted from the payment of federal
27 income taxes as provided by section 501(c)(8) or section 501(c)(10) of the
28 federal internal revenue code of 1986, as amended, or determined to be
29 organized and operated as a bona fide nonprofit fraternal organization by
30 the administrator.

31 (t) "Nonprofit educational organization" means any public or private
32 elementary or secondary school or institution of higher education which
33 has been determined by the administrator to be organized and operated as a
34 bona fide educational organization and which has been exempted from the
35 payment of federal income taxes as provided by section 501(c)(3) of the
36 federal internal revenue code of 1986, as amended, or determined to be
37 organized and operated as a bona fide nonprofit educational organization
38 by the administrator.

39 (u) "Nonprofit veterans' organization" means any organization within
40 this state or any branch, lodge or chapter of a national or state organization
41 within this state, the membership of which consists exclusively of
42 individuals who qualify for membership because they were or are
43 members of the armed services or forces of the United States, or an

1 auxiliary unit or society of such a nonprofit veterans' organization, the
2 membership of which consists exclusively of individuals who were or are
3 members of the armed services or forces of the United States, or are
4 cadets, or are spouses, widows or widowers of individuals who were or are
5 members of the armed services or forces of the United States, and of
6 which no part of the net earnings inures to the benefit of any private
7 shareholder or individual member of such organization, and has been
8 determined by the administrator to be organized and operated as a bona
9 fide veterans' organization and which has been exempted from the
10 payment of federal income taxes as provided by section 501(c)(4) or
11 501(c)(19) of the federal internal revenue code of 1986, as amended, or
12 determined to be organized and operated as a bona fide nonprofit veterans'
13 organization by the administrator.

14 (v) "Person" means any natural person, corporation, partnership, trust
15 or association.

16 (w) "Premises" means any room, hall, building, enclosure or outdoor
17 area used for the management, operation or conduct of a game of bingo by
18 a licensee.

19 (x) "Progressive bingo" means a game of call bingo in which either
20 the established prize amount or number of bingo balls or objects called, or
21 both, may be increased from one session to the next scheduled session if
22 no player completes the required pattern within the specified number of
23 bingo balls or objects drawn. The player's opportunity to win shall increase
24 as the prize amount increases.

25 (y) "Raffle" means a game of chance in which each participant buys a
26 ticket or tickets from a nonprofit organization with each ticket providing
27 an equal chance to win a prize and the winner being determined by a
28 random drawing.

29 (z) "Reusable bingo card" means a reusable card which is marked off
30 into 25 squares arranged in five horizontal rows of five squares each and
31 five vertical rows of five squares each, with each square being designated
32 by a number, letter or combination of numbers and letters. Only the center
33 square shall be designated with the word "free." No two cards in the same
34 game shall be identical.

35 (aa) "Secretary" means the secretary of revenue or the secretary's
36 designee.

37 (bb) "Session" means a day on which a licensee conducts games of
38 bingo.

39 New Sec. 4. (a) The power to regulate, license and tax the
40 management, operation and conduct of and participation in games of bingo
41 and raffles is hereby vested exclusively in the state.

42 (b) The raffle of a motor vehicle shall be deemed an isolated or
43 occasional sale of such motor vehicle to the raffle winner and subject to

1 retailer's sales tax pursuant to K.S.A. 79-3603(o), and amendments thereto.

2 New Sec. 5. (a) Any bona fide nonprofit religious, charitable,
3 fraternal, educational or veterans' organization desiring to manage, operate
4 or conduct games of bingo or raffles within the state of Kansas may make
5 application for a license therefor in the manner provided under this
6 section. Application for licenses required under the provisions of this act
7 shall be made to the administrator upon forms prescribed by the
8 administrator. The application shall contain:

9 (1) The name and address of the organization;

10 (2) the particular place or location or multiple locations or premises
11 for which a license is desired;

12 (3) a sworn statement verifying that such organization is a bona fide
13 nonprofit religious, charitable, fraternal, educational or veterans'
14 organization authorized to operate within the state of Kansas signed by the
15 presiding officer and secretary of the organization; and

16 (4) such other information as may be required by the administrator.

17 (b) An application for a bingo license required under the provisions
18 of this act shall be accompanied by a fee of \$25.

19 (c) (1) No license shall be required for any nonprofit religious,
20 charitable, fraternal, educational or veterans' organization which conducts
21 raffles the annual gross receipts which do not exceed \$25,000.

22 (2) Any such nonprofit organization which has annual gross receipts
23 exceeding \$25,000 from raffles shall pay an annual fee according to the
24 following schedule:

25 (A) Nonprofit organizations where annual gross receipts are more
26 than \$25,000 but do not exceed \$50,000 shall pay a license fee of \$25.

27 (B) Nonprofit organizations where annual gross receipts which
28 exceed \$50,000 but do not exceed \$75,000 shall pay a license fee of \$50.

29 (C) Nonprofit organizations where annual gross receipts exceed
30 \$75,000 but do not exceed \$100,000 shall pay a license fee of \$75.

31 (D) Nonprofit organizations where annual gross receipts exceed
32 \$100,000 shall pay a fee of \$100.

33 (3) Upon recommendations of the administrator, the secretary shall
34 adopt rules and regulations to implement the license requirements for
35 nonprofit organizations conducting raffles.

36 (d) No charitable gaming licensee shall use an electronic gaming
37 device to sell raffle tickets or to conduct raffles. No raffle licensee shall
38 contract with a professional raffle or lottery vendor to manage, operate or
39 conduct any raffle.

40 (e) All licenses issued under the provisions of this act shall be issued
41 in the name of the organization licensed.

42 (f) No bingo license or raffle license shall be issued to any bona fide
43 nonprofit religious, charitable, fraternal, educational or veterans'

1 organization if any of its officers, directors or officials or persons
2 employed on the premises:

3 (1) Have been convicted of, have pleaded guilty to or pleaded nolo
4 contendere to a violation of gambling laws of any state or the gambling
5 laws of the United States, or shall have forfeited bond to appear in court to
6 answer charges for any such violation, or have been convicted or pleaded
7 guilty or pleaded nolo contendere to the violation of any law of this or any
8 other state which is classified as a felony under the laws of such state; or

9 (2) at the time of application for renewal of a bingo license or raffle
10 license issued hereunder would not be eligible for such license upon a first
11 application.

12 (g) Each bingo license, raffle license and bingo certificate issued shall
13 expire at midnight on June 30 following its date of issuance.

14 (h) A bingo licensee may hold only one license. Any licensee may
15 operate or conduct games of bingo at locations that are specified in the
16 license. However, any licensee may operate or conduct games of bingo at
17 locations other than that specified in the license upon approval of the
18 administrator. If any licensee does operate or conduct games of bingo
19 under this provision at a location other than that specified in the license,
20 such licensee shall submit a written notification to the administrator, three
21 days prior to operating or conducting bingo at such other location. No
22 organization shall be issued a license to operate or conduct games of bingo
23 at any location outside the county or an adjoining county within which
24 such organization is located as reported in its application for licensure
25 pursuant to subsection (a). Licenses issued under the provisions of this act
26 shall not be transferred or assignable. If any organization licensed to play
27 bingo changes any of its officers, directors or officials during the term of
28 its bingo license, such organization shall report the names and addresses of
29 such individuals to the administrator immediately with the sworn
30 statement of each such individual as required by this section on forms
31 prescribed by the administrator. No organization which denies its
32 membership to persons for the reason of their race, color or physical
33 handicap, shall be granted or allowed to retain a license issued under the
34 authority of this act. Except for nonprofit adult care homes licensed under
35 the laws of the state of Kansas, no license shall be issued to any
36 organization under the provisions of this act which has not been in
37 existence continuously within the state of Kansas for a period of 18
38 months immediately preceding the date of making application for a
39 license. The licensee shall display the license in a prominent place in the
40 vicinity of the area where it is to conduct bingo.

41 (i) No lessor of premises used for the management, operation or
42 conduct of any games of bingo shall permit the management, operation or
43 conduct of bingo games on such premises unless such lessor has been

1 issued a registration certificate by the administrator. Application for
2 registration shall be accompanied by a fee of \$100. Such application shall
3 be made upon forms prescribed by the administrator and shall be
4 submitted to the administrator. The application shall contain:

5 (1) The name or names of the lessor of the premises which will be
6 used for the management, operation or conduct of any games of bingo
7 including, in the case of a corporation, partnership, association, trust or
8 other entity, the names of all individuals having more than a 10%
9 ownership interest, either directly or indirectly in such entity;

10 (2) the address of such premises;

11 (3) the name or names of any and all organizations which will
12 manage, operate or conduct any games of bingo on such premises during
13 the period for which the registration certificate is valid; and

14 (4) such other information as may be required by the administrator.

15 (j) Each registration certificate, or renewal thereof, issued under the
16 provisions of subsection (g) shall expire at midnight on June 30 following
17 its date of issuance. The certificate of registration shall be valid for only
18 one premises and shall be displayed in a prominent place in the registered
19 premises.

20 (k) No registration certificate issued under provisions of subsection
21 (g) shall be issued for any premises if any individual who is connected in
22 any way, directly or indirectly, with the owner or lessor of the premises,
23 within five years prior to registration, has been convicted of or pleaded
24 guilty or nolo contendere to any felony or illegal gambling activity or
25 purchased a tax stamp for wagering or gambling activity.

26 (l) Any bona fide nonprofit religious, charitable, fraternal, educational
27 or veterans' organization that conducts charitable raffles for which the
28 aggregate gross receipts from such raffles in the calendar year does not
29 exceed \$25,000 shall be exempt from the provisions of this section, except
30 that such organization shall be subject to the provisions of subsection (d)
31 regarding how such raffles are managed, operated and conducted.

32 New Sec. 6. For the purpose of providing revenue which may be used
33 by the state and for the privilege of operating or conducting games of
34 bingo under the authority of this act:

35 (a) There is hereby levied and there shall be collected and paid by
36 each licensee a tax at the rate of 3% upon the gross receipts received by
37 the licensee from charges for participation in call bingo games using
38 reusable bingo cards and any admission fees or charges. The tax imposed
39 by this section shall be in addition to the license fee imposed under K.S.A.
40 79-4703, and amendments thereto.

41 (b) There is hereby levied and there shall be collected and paid by
42 each distributor a tax at a rate of \$0.002 upon each bingo face sold or
43 distributed by the distributor to each licensee conducting call bingo games

1 within the state of Kansas. The distributor shall include the tax due under
2 this subsection in the sales price of each bingo face paid by the licensee
3 and such tax shall be itemized separately on the invoice provided to the
4 licensee.

5 (c) There is hereby levied and there shall be collected and paid by
6 each distributor a tax at a rate of 1% upon the total of the printed retail
7 sales price of all tickets in each box of instant bingo tickets sold or
8 distributed by the distributor to each licensee conducting instant bingo
9 games within the state of Kansas. The distributor shall include the tax due
10 under this subsection in the sales price of each box paid by the licensee
11 and such tax shall be itemized separately on the invoice provided to the
12 licensee.

13 (d) If a distributor does not receive payment in full from a licensed
14 organization within 60 days of the delivery of call bingo and instant bingo
15 supplies, the supplier shall notify the department of charitable gaming in
16 writing of the delinquency. Upon receipt of the notice of delinquency, the
17 department of charitable gaming may revoke or suspend the license.

18 (e) Whenever, in the judgment of the administrator, it is necessary, in
19 order to secure the collection of the tax due under subsection (b), the
20 administrator shall require any distributor subject to such tax to file a bond
21 with the director under conditions established by and in such form and
22 amount as prescribed by rules and regulations adopted by the secretary.

23 New Sec. 7. (a) On dates prescribed by the administrator, every
24 licensee conducting bingo shall make a return to the administrator upon
25 forms prescribed by the administrator. Such form shall contain:

- 26 (1) The name and address of the licensee;
- 27 (2) the amount of the gross receipts received from charges for
28 participation in games using bingo cards during the preceding reporting
29 period;
- 30 (3) the number of bingo faces and the name of the distributor from
31 whom such faces were purchased or otherwise obtained during the
32 preceding reporting period;
- 33 (4) the amount of the gross receipts received from charges for
34 admission to the premises for participation in games of bingo during the
35 preceding reporting period;
- 36 (5) the number of each denomination of instant bingo tickets sold
37 during the preceding reporting period; and
- 38 (6) such other information as the administrator may deem necessary.

39 (b) On dates prescribed by the administrator, every licensee
40 conducting raffles for which a license fee is required pursuant to section 5,
41 and amendments thereto, shall make a return to the administrator upon
42 forms prescribed by the administrator. Such form shall contain:

- 43 (1) The name and address of the licensee;

1 (2) the amount of gross receipts received from raffles conducted by
2 the licensee; and

3 (3) any other information deemed necessary by the administrator.

4 (c) On dates prescribed by the administrator, every distributor shall
5 make a return to the administrator upon forms prescribed by the
6 administrator. Such form shall state:

7 (1) The number of instant bingo tickets sold or distributed to each
8 licensee;

9 (2) the amount of the retail sales price of such tickets;

10 (3) the number of bingo cards sold or distributed to each licensee;

11 (4) the number of bingo faces sold or distributed to each licensee; and

12 (5) such other information as the administrator may deem necessary.

13 At the time of making such return, the distributor shall remit to the
14 administrator an amount equal to 98% of the tax due under section 6(b),
15 and amendments thereto.

16 (d) If any licensee or distributor fails to make a return or remit any
17 tax, when required to do so by the provisions of this act, except in the case
18 of an extension of time granted by the administrator, there shall be added
19 to the tax determined to be due a penalty of 25% of the amount of such
20 tax, together with interest at the rate per month prescribed by K.S.A. 79-
21 2968(a), and amendments thereto, from the date the tax was due until paid.

22 (e) If any tax determined and assessed by the administrator is not
23 remitted due to fraud with intent to evade the tax imposed by this act, there
24 shall be added thereto a penalty of 50% of the amount of such tax, together
25 with interest at the rate per month prescribed by K.S.A. 79-2968(a), and
26 amendments thereto, from the date the tax was due until paid.

27 (f) Whenever, in the judgment of the administrator, the failure of any
28 licensee or distributor to comply with the provisions of subsection (a), (b),
29 (c) or (d) was due to reasonable cause, the administrator, in the
30 administrator's discretion, may waive or reduce any of the penalties or
31 interest imposed by this section, upon making a record of the reason
32 therefor.

33 (g) The penalties imposed under this section shall be in addition to all
34 other penalties imposed by law.

35 New Sec. 8. (a) For the purpose of ascertaining the correctness of any
36 return or for the purpose of determining the receipts and remittances of
37 any licensee or distributor, the administrator may examine any books,
38 papers, records or memoranda, bearing upon the matters required to be
39 included in the records of the licensee or distributor. The administrator
40 may require the attendance of the licensee or distributor in the county
41 where the licensee or distributor resides, or where the location of the
42 registered premises for bingo games or raffles are located, or of any person
43 having knowledge relating to such records, and may take testimony and

1 require proof of such person or persons.

2 (b) The administrator may issue subpoenas to compel access to or for
3 the production of such books, papers, records or memoranda in the custody
4 of or to which the licensee or distributor has access, or to compel the
5 appearance of such persons. The administrator may issue interrogatories to
6 any such person to the same extent and subject to the same limitations as
7 would apply if the subpoena or interrogatories were issued or served in aid
8 of a civil action in the district court. The administrator may administer
9 oaths and take depositions to the same extent and subject to the same
10 limitations as would apply if the deposition was in aid of a civil action in
11 the district court. In case of the refusal of any person to comply with any
12 subpoena or interrogatory or to testify to any matter regarding which such
13 person lawfully may be questioned, the district court of any county, upon
14 application of the administrator, may order such person to comply with
15 such subpoena or interrogatory or to testify. Failure to obey the court's
16 order may be punished by the court as contempt. Subpoenas or
17 interrogatories issued under the provisions of this section may be served
18 upon individuals and corporations in the manner provided in K.S.A. 60-
19 304, and amendments thereto, for the service of process by any officer
20 authorized to serve subpoenas in civil actions or by the administrator.

21 New Sec. 9. Games of bingo shall be managed, operated and
22 conducted in accordance with the Kansas charitable gaming act and rules
23 and regulations adopted pursuant thereto and the following restrictions:

24 (a) The entire gross receipts received by any licensee from the
25 operation or conduct of games of bingo, except that portion utilized for the
26 payment of the cost of prizes and license fees and taxes on games of bingo
27 imposed under the provisions of this act, shall be used exclusively for the
28 lawful purposes of the licensee permitted to conduct that game.

29 (b) Games of bingo shall be managed, conducted or operated by a
30 bona fide member or spouse of a bona fide member of the licensee or
31 parent organization, an auxiliary unit or society or a beneficiary
32 organization of such licensee or of the beneficiary organization. During
33 each session of bingo there must be at least one member of the licensee
34 organization on duty and assisting with the game. Such member must be
35 listed with the office of charitable gaming.

36 (c) No person may participate in the management, conduct or
37 operation of bingo games or raffles by a licensee if such person, within
38 five years prior to such participation, has been convicted of or pleaded
39 guilty or nolo contendere to any felony or illegal gambling activity or
40 purchased a tax stamp for wagering or gambling activity.

41 (d) No person may receive any remuneration or profit for
42 participating in the management, conduct or operation of any game of
43 bingo or any raffle managed, conducted or operated by a licensee unless

1 such remuneration or profit goes to the benefit of another nonprofit group.
2 Any employee of the licensee, however, may assist in the conduct of any
3 charitable gaming event.

4 (e) (1) The aggregate value of all prizes including the retail value of
5 all merchandise awarded or offered by a licensee in a single session to
6 winners of games of call bingo shall not exceed \$1,200. The administrator
7 shall increase the call bingo cap on July 1 of each year to reflect changes
8 in the consumer price index for all urban consumers as published by the
9 United States department of labor for the preceding calendar year. The
10 value of a prize awarded in a progressive or mini bingo game shall not be
11 included when determining the limit imposed by this subsection. Any
12 monetary prize of \$1,199 or more awarded in games of bingo shall be paid
13 by a check drawn on the bingo trust bank account of the licensee. Any
14 monetary prize awarded in games of bingo shall be paid by a check on the
15 bingo trust bank account of the licensee upon the request of the winner of
16 such award.

17 (2) Charitable raffle licensees shall report to the department the name
18 and address of all raffle winners of any prize the retail value of which is
19 \$1,199 or more.

20 (f) The retail value of any merchandise received by a winner of a
21 bingo game shall be considered as the cash value for the purposes of
22 determining the value of the prize.

23 (g) Each licensee shall keep a record of all games of bingo and
24 charitable raffles managed, operated or conducted by it for a period of
25 three years following the date the game is managed, operated or
26 conducted.

27 (h) No person under the age of 18 years shall participate in the
28 management, operation or conduct of any game of bingo managed,
29 operated or conducted by a licensee under the provisions of this act and no
30 licensee shall sell any instant bingo ticket to a person under the age of 18
31 years.

32 (i) No licensee shall manage, operate or conduct bingo on any leased
33 premises or with leased equipment unless all of the terms and conditions
34 of rental or use, including the rental of chairs, bingo equipment, tables,
35 security guards, janitor service or any other services, are set forth in a lease
36 submitted, approved and on file with the administrator.

37 (j) Every licensee who has gross receipts of \$1,000 or more received
38 from participation in games, admission fees or charges and from any other
39 source directly related to the operation or conduct of any games of bingo
40 in any calendar month shall maintain a bingo trust bank account into
41 which all such receipts are deposited daily and from which all payments
42 are made relating to the management, operation or conduct of any games
43 of bingo. Having once established such bingo trust bank account, the

1 licensee shall continue to make deposits of all receipts therein. Every
2 licensee shall notify the administrator of the name of the bank in which the
3 bingo trust bank account is maintained, together with the number and
4 name of the account. Every licensee who maintains a bingo trust bank
5 account shall maintain a complete record of all deposits and withdrawals

16 on the face thereof a unique serial number which shall not be repeated on
17 the same manufacturer's form number less than every three years. All
18 instant bingo tickets shall be sold or distributed in boxes. Each box shall
19 be sealed by the manufacturer with a seal which includes a warning to the
20 purchaser that the box may have been tampered with if the box was
21 received by the purchaser with the seal broken. Each box of instant bingo
22 tickets shall contain tickets printed in such a manner as to insure that at
23 least 60% of the gross revenues generated by the ultimate sale of all tickets
24 from such box shall be returned to the final purchasers of such tickets. No
25 box of instant bingo tickets may be opened by a licensee unless all tickets
26 contained in a previously opened box with the same form number have
27 been sold.

28 (m) Each box of instant bingo tickets sold or distributed to licensees
29 shall be accompanied by a flare which contains the following information:
30 (1) The name of the game; (2) the manufacturer's name or logo; (3) the
31 game form number; (4) the ticket count in the game; (5) the prize structure
32 for the game, which includes the number of winning tickets by
33 denomination and their respective winning symbol or number
34 combinations; (6) the cost per ticket; (7) the game serial number; and (8)
35 the winning numbers or symbols for the top three winning tiers set out in
36 such a manner that each prize may be marked off as the prize is won and
37 awarded.

38 (n) (1) Progressive bingo games may be conducted in conjunction
39 with a session of bingo.

40 (2) A licensee shall not cease bingo operations unless all progressive
41 bingo games are completed and prizes are awarded, unless prior approval
42 has been received from the secretary.

43 (3) The rules for a progressive bingo game shall remain in effect until

1 the game ends and the winner is determined.

2 (4) All progressive bingo games and rules for such games shall be
3 described fully and posted in the house rules prior to the start of the
4 session. Such games shall comply with requirements imposed under the
5 Kansas charitable gaming act and any rules and regulations adopted
6 pursuant thereto.

7 (5) When a person achieves the first preannounced winning
8 combination, the game shall be completed and the next progressive bingo
9 game and winning combination shall be commenced with a new bingo

25 New Sec. 10. (a) The administrator, after a hearing in accordance
