1 AN ACT concerning motor vehicles; relating to vehicle registration, fees;
2 creating the Kansas highway patrol staffing and training fund; law
3 enforcement training center fund; amending K.S.A. 2015 Supp. 8-145
4 ***{and 74-5619}*** and repealing the existing ~~section~~ *{sections}*.

6 *Be it enacted by the Legislature of the State of Kansas:*

7 New Section 1. ***{(a)}*** There is hereby created in the state treasury, the
8 Kansas highway patrol staffing and training fund. Moneys credited to the
9 Kansas highway patrol staffing and training fund shall be used by the
10 highway patrol for increasing employment and retaining personnel at the
11 highway patrol and for no other purpose. All expenditures from the Kansas
12 highway patrol staffing and training fund shall be made in accordance with
13 appropriation acts upon warrants of the director of accounts and reports
14 issued pursuant to vouchers approved by the superintendent of the
15 highway patrol.

16 ***{(b)}*** *The funds shall be used for the purposes set forth in this*
17 *section and for no other governmental purposes. It is the intent of the*
18 *legislature that the funds and the moneys deposited in this fund shall*
19 *remain intact and inviolate for the purposes set forth in this section.*

20 New Sec. 2. In addition to any registration fee prescribed under
21 article 1 of chapter 8 of the Kansas Statutes Annotated, and amendments
22 thereto, all applicants for vehicle registration shall pay at the time of
23 registration a nonrefundable Kansas highway patrol staffing and training
24 surcharge in the amount of \$2 for each vehicle being registered.

25 New Sec. 3. In addition to any registration fee prescribed under
26 article 1 of chapter of the Kansas Statutes Annotated, and amendments
27 thereto, all applicants for vehicle registration shall pay, at the time of
28 registration, a nonrefundable law enforcement training center surcharge in
29 the amount of \$1.25 for each vehicle being registered.

30 Sec. 4. K.S.A. 2015 Supp. 8-145 is hereby amended to read as
31 follows: 8-145. (a) All registration and certificates of title fees shall be
32 paid to the county treasurer of the county in which the applicant for
33 registration resides or has an office or principal place of business within
34 this state, and the county treasurer shall issue a receipt in triplicate, on
35 blanks furnished by the division of vehicles, one copy of which shall be
36 filed in the county treasurer's office, one copy shall be delivered to the

1 applicant and the original copy shall be forwarded to the director of
2 vehicles.

3 (b) The county treasurer shall deposit \$.75 of each license
4 application, \$.75 out of each application for transfer of license plate and \$2
5 out of each application for a certificate of title, collected by such treasurer
6 under this act, in a special fund, which fund is hereby appropriated for the
7 use of the county treasurer in paying for necessary help and expenses
8 incidental to the administration of duties in accordance with the provisions
9 of this law and extra compensation to the county treasurer for the services
10 performed in administering the provisions of this act, which compensation
11 shall be in addition to any other compensation provided by any other law,
12 except that the county treasurer shall receive as additional compensation
13 for administering the motor vehicle title and registration laws and fees, a
14 sum computed as follows: The county treasurer, during the month of
15 December, shall determine the amount to be retained for extra
16 compensation not to exceed the following amounts each year for calendar
17 year 2006 or any calendar year thereafter: The sum of \$110 per hundred
18 registrations for the first 5,000 registrations; the sum of \$90 per hundred
19 registrations for the second 5,000 registrations; the sum of \$5 per hundred
20 for the third 5,000 registrations; and the sum of \$2 per hundred
21 registrations for all registrations thereafter. In no event, however, shall any
22 county treasurer be entitled to receive more than \$15,000 additional annual
23 compensation.

24 If more than one person shall hold the office of county treasurer during
25 any one calendar year, such compensation shall be prorated among such
26 persons in proportion to the number of weeks served. The total amount of
27 compensation paid the treasurer together with the amounts expended in
28 paying for other necessary help and expenses incidental to the
29 administration of the duties of the county treasurer in accordance with the
30 provisions of this act, shall not exceed the amount deposited in such
31 special fund. Any balance remaining in such fund at the close of any
32 calendar year shall be withdrawn and credited to the general fund of the
33 county prior to June 1 of the following calendar year.

34 (c) The county treasurer shall remit the remainder of all such fees
35 collected, together with the original copy of all applications, to the
36 secretary of revenue. The secretary of revenue shall remit all such fees
37 remitted to the state treasurer in accordance with the provisions of K.S.A.
38 75-4215, and amendments thereto. Upon receipt of each such remittance,
39 the state treasurer shall deposit the entire amount in the state treasury to
40 the credit of the state highway fund, except as provided in subsection (d).

41 (d) (1) Three dollars and fifty cents of each certificate of title fee
42 collected and remitted to the secretary of revenue, shall be remitted to the
43 state treasurer who shall credit such \$3.50 to the Kansas highway patrol

1 motor vehicle fund. Three dollars of each certificate of title fee collected
2 and remitted to the secretary of revenue, shall be remitted to the state
3 treasurer who shall credit such \$3 to the VIPS/CAMA technology
4 hardware fund.

5 (2) For repossessed vehicles, \$3 of each certificate of title fee
6 collected and remitted to the secretary of revenue, shall be remitted to the
7 state treasurer who shall credit such \$3 to the repossessed certificates of
8 title fee fund.

9 (3) Three dollars and fifty cents of each reassignment form fee
10 collected and remitted to the secretary of revenue, shall be remitted to the
11 state treasurer who shall credit such \$3.50 to the Kansas highway patrol
12 motor vehicle fund. Three dollars of each reassignment form fee collected
13 and remitted to the secretary of revenue, shall be remitted to the state
14 treasurer who shall credit such \$3 to the VIPS/CAMA technology
15 hardware fund.

16 (4) Until January 1, 2013, \$4 of each division of vehicles
17 modernization surcharge collected and remitted to the secretary of
18 revenue, shall be remitted to the state treasurer who shall credit such \$4 to
19 the division of vehicles modernization fund, on and after January 1, 2013,
20 the state treasurer shall credit such \$4 to the state highway fund.

21 (5) *Two dollars of each Kansas highway patrol staffing and training*
22 *surcharge collected and remitted to the secretary of revenue, shall be*
23 *remitted to the state treasurer who shall credit such \$2 to the Kansas*
24 *highway patrol staffing and training fund.*

25 (6) *One dollar and twenty-five cents of each law enforcement*
26 *training center surcharge collected and remitted to the secretary of*
27 *revenue, shall be remitted to the state treasurer who shall credit such*
28 *\$1.25 to the law enforcement training center fund.*

29 **{Sec. 5. K.S.A. 2015 Supp. 74-5619 is hereby amended to read as**
30 **follows: 74-5619. (a) (1) There is hereby created in the state treasury the**
31 **law enforcement training center fund. All moneys credited to such fund**
32 **under the provisions of this act or any other law shall be expended only**
33 **for the purpose and in the manner prescribed by law.**

34 (2) *All moneys received for assessments as provided pursuant to*
35 *K.S.A. 74-5607, and amendments thereto, shall be remitted to the state*
36 *treasurer in accordance with the provisions of K.S.A. 75-4215, and*
37 *amendments thereto. Upon receipt of each such remittance, the state*
38 *treasurer shall deposit the entire amount in the state treasury to the*
39 *credit of the law enforcement training center fund.*

40 (b) *There is hereby created in the state treasury the Kansas*
41 *commission on peace officers' standards and training fund. All moneys*
42 *credited to such fund under the provisions of this act or any other law*
43 *shall be expended only for the purpose of the operation of the*

1 *commission to carry out its powers and duties as mandated by law. The*
2 *director may apply for and receive public or private grants, gifts and*
3 *donations of money for the commission. All moneys received from*
4 *grants, gifts and donations shall be remitted to the state treasurer in*
5 *accordance with the provisions of K.S.A. 75-4215, and amendments*
6 *thereto. Upon receipt of each such remittance, the state treasurer shall*
7 *deposit the entire amount in the state treasury to the credit of the Kansas*
8 *commission on peace officers' standards and training fund.*

9 *(c) The funds shall be used for the purposes set forth in this section*
10 *and for no other governmental purposes. It is the intent of the legislature*
11 *that the funds and the moneys deposited in these funds shall remain intact*
12 *and inviolate for the purposes set forth in this section.*

13 *(d) This section shall be part of and supplemental to the Kansas law*
14 *enforcement training act.}*
