1 AN ACT concerning children and minors; relating to juvenile justice;

13 *Be it enacted by the Legislature of the State of Kansas:*

14 New Section 1. (a) Upon adjudication as a juvenile offender pursuant
15 to K.S.A. 2015 Supp. 38-2356, and amendments thereto, modification of
16 sentence pursuant to K.S.A. 2015 Supp. 38-2367, and amendments thereto,
17 or violation of a condition of sentence pursuant to K.S.A. 2015 Supp. 38-
18 2368, and amendments thereto, the court may impose one or more of the
19 sentencing alternatives under K.S.A. 2015 Supp. 38-2361, and
20 amendments thereto, for a period of time pursuant to this section and
21 K.S.A. 2015 Supp. 38-2369, and amendments thereto. The period of time
22 ordered by the court shall not exceed the overall case length limit.

23 (b) ***Except as provided in subsection (c)***, the overall case length limit
24 shall be calculated based on the adjudicated offense and the results of a
25 risk and needs assessment, as follows:

26 (1) Offenders adjudicated for a misdemeanor may remain under the
27 jurisdiction of the court for up to 12 months;

28 (2) low-risk and moderate-risk offenders adjudicated for a felony may
29 remain under court jurisdiction for up to 15 months; and

30 (3) high-risk offenders adjudicated for a felony may remain under
31 court jurisdiction for up to 18 months, ~~except that-~~

32 ~~(A) Any offender, regardless of risk level, adjudicated for a felony~~
33 ~~that, if committed by an adult, would constitute a severity level 1 through~~
34 ~~3, person felony, may be under court jurisdiction for up to 30 months,~~
35 ~~except as provided in subparagraph (B); and~~

36 ~~(B) any offender, regardless of risk level, adjudicated for a felony~~

1 that, if committed by an adult, would constitute an off-grid felony, rape as
2 defined in K.S.A. 2015 Supp. 21-5503, and amendments thereto,
3 aggravated criminal sodomy as defined in K.S.A. 2015 Supp. 21-5504(b)
4 (3), and amendments thereto, or murder in the second degree as defined in
5 K.S.A. 2015 Supp. 21-5403, and amendments thereto, may be under court
6 jurisdiction for up to 42 months or up to 66 months if the judge conducts a
7 departure hearing and finds substantial and compelling reasons to impose a
8 departure sentence as provided in K.S.A. 2015 Supp. 38-2371, and
9 amendments thereto.

10 *(c) There shall be no overall case length limit for a juvenile*
11 *adjudicated for a felony that, if committed by an adult, would constitute*
12 *an off-grid felony or a nondrug severity level 1 through 4 person felony.*

13 ~~(d)~~ When a juvenile is adjudicated for multiple counts, the
14 maximum overall case length shall be calculated based on the most severe
15 adjudicated count or any other adjudicated count at the court's discretion.
16 The court shall not run multiple adjudicated counts consecutively.

17 ~~(d)~~*(e)* When the juvenile is adjudicated for multiple cases
18 simultaneously, the court shall run those cases concurrently.

19 ~~(e)~~*(f)* Upon expiration of the overall case length limit as defined in
20 subsection (b), the court's jurisdiction terminates and shall not be
21 extended.

22 ~~(f)~~*(g)* (1) For the purposes of placing juvenile offenders on probation
23 pursuant to K.S.A. 2015 Supp. 38-2361, and amendments thereto, the
24 court shall establish a specific term of probation as specified in this
25 subsection based on the most serious adjudicated count in combination
26 with the results of a risk and needs assessment, as follows, except that the
27 term of probation shall not exceed the overall case length limit:

28 (A) Low-risk and moderate-risk offenders adjudicated for a
29 misdemeanor and low-risk offenders adjudicated for a felony may be
30 placed on probation for a term up to six months;

31 (B) high-risk offenders adjudicated for a misdemeanor and moderate-
32 risk offenders adjudicated for a felony may be placed on probation for a
33 term up to nine months;

34 (C) high-risk offenders adjudicated for a felony may be placed on
35 probation for a term up to 12 months.

36 (2) The court may only extend the term of probation if a juvenile
37 needs time to complete an evidence-based program ~~that the juvenile has~~
38 ~~already begun~~ *as determined to be necessary based on the results of a*
39 *validated risk and needs assessment.* Prior to extension of the initial
40 probationary term, the court shall find and enter into the written record the
41 criteria permitting extension of probation. Extensions of probation shall
42 only be granted incrementally and shall not exceed the overall case length
43 limit.

1 (3) The probation term limits do not apply to those offenders
2 adjudicated for an off-grid crime, rape as defined in K.S.A. 2015 Supp. 21-
3 5503(a)(1), and amendments thereto, aggravated criminal sodomy as
4 defined in K.S.A. 2015 Supp. 21-5504(b)(3), and amendments thereto, or
5 murder in the second degree as defined in K.S.A. 2015 Supp. 21-5403, and
6 amendments thereto. Such offenders may be placed on probation for a
7 term consistent with the overall case length limit.

8 ~~(g)~~**(h)** For the purpose of placing juvenile offenders in detention
9 pursuant to K.S.A. 2015 Supp. 38-2361 and 38-2369, and amendments
10 thereto, the court shall establish a specific term of detention. The term of
11 detention shall not exceed the overall case length limit or the cumulative
12 detention limit. Cumulative detention use shall be limited to a maximum
13 of 30 days over the course of the juvenile offender's case, ***except that***
14 ***there shall be no limit on cumulative detention for juvenile offenders***
15 ***adjudicated for a felony that, if committed by an adult, would constitute***
16 ***an off-grid felony or a nondrug severity level 1 through 4 person felony.***

17 ~~(h)~~**(i)** This section shall be part of and supplemental to the revised
18 Kansas juvenile justice code.

19 New Sec. 2. (a) The department of corrections shall, in consultation
20 with the supreme court, adopt rules and regulations ***by January 1, 2017,***
21 for a statewide system of structured community-based graduated responses
22 for technical violations of probation, violations of conditional release and
23 violations of a condition of sentence by juveniles. Such graduated
24 responses shall be utilized by community supervision officers to provide a
25 continuum of community-based responses. These responses shall include
26 sanctions that are swift and certain to address violations based on the
27 severity of the violation as well as incentives that encourage positive
28 behaviors. Such responses shall take into account the juvenile's risks and
29 needs.

30 (b) When a juvenile is placed on probation pursuant to K.S.A. 2015
31 Supp. 38-2361, and amendments thereto, community supervision officers
32 shall utilize graduated responses, targeted to the juvenile's risks and needs
33 based on the results of a risk and needs assessment to address technical
34 violations. A technical violation shall only be considered by the court for
35 revocation if: (1) It is a third or subsequent technical violation; (2) prior
36 failed responses are documented in the juvenile's case plan; and (3) the
37 community supervision officer has determined and documented that
38 graduated responses to the violation will not suffice. Unless a juvenile
39 poses a significant risk of physical harm to another ***or damage to property,***
40 community supervision officers shall issue a summons rather than request
41 a warrant on a third or subsequent technical violation subject to review by
42 the court.

43 (c) When a juvenile is placed on probation pursuant to K.S.A. 2015

1 Supp. 38-2361, and amendments thereto, the community supervision
2 officer responsible for oversight of the juvenile shall develop a case plan in
3 consultation with the juvenile and the juvenile's family. The department for
4 children and families and local board of education may participate in the
5 development of the case plan when appropriate.

6 (1) Such case plan shall incorporate the results of the risk and needs
7 assessment, referrals to programs, documentation on violations and
8 graduated responses and shall clearly define the role of each person or
9 agency working with the juvenile.

10 (2) If the juvenile is later committed to the custody of the secretary,
11 the case plan shall be shared with the juvenile correctional facility.

12 (d) This section shall be part of and supplemental to the revised
13 Kansas juvenile justice code.

14 New Sec. 3. (a) (1) The court shall appoint a multidisciplinary team
15 to review cases in which a juvenile fails to substantially comply with the
16 development of the immediate intervention plan pursuant to K.S.A. 2015
17 Supp. 38-2346(b), and amendments thereto. The team may be a standing
18 multidisciplinary team or may be appointed for a specific juvenile. (2) The
19 supreme court shall appoint a multidisciplinary team facilitator in each
20 judicial district. The supreme court may appoint a convener and facilitator
21 for a multiple district multidisciplinary team.

22 (b) The multidisciplinary team facilitator shall invite the following
23 individuals to be part of the multidisciplinary team:

24 (1) The juvenile;

25 (2) the juvenile's parents, guardians or custodial relative;

26 (3) the superintendent of schools or the superintendent's designee;

27 (4) a clinician who has training and experience coordinating
28 behavioral or mental health treatment for juveniles *if such clinician is*
29 *available*; and

30 (5) any other person or agency representative who ~~may~~ *is needed to*
31 assist in providing recommendations for the particular needs of the
32 juvenile and family.

33 (c) Any person appointed as a member of a multidisciplinary team
34 may decline to serve and shall incur no civil liability as a result of
35 declining to serve.

36 (d) This section shall take effect on and after January 1, 2017.

37 New Sec. 4. (a) There is hereby established the Kansas juvenile
38 justice oversight committee for the purpose of overseeing the
39 implementation of reform measures intended to improve the state's
40 juvenile justice system.

41 (b) The Kansas juvenile justice oversight committee shall be
42 composed of ~~18~~ **19** members including the following individuals:

43 (1) The governor or the governor's designee;

1 (2) one member of the house of representatives appointed by the
2 speaker of the house of representatives;

3 (3) one member of the house of representatives appointed by the
4 minority leader of the house of representatives;

5 (4) one member of the senate appointed by the president of the
6 senate;

7 (5) one member of the senate appointed by the minority leader of the
8 senate;

9 (6) the secretary of corrections or the secretary's designee;

10 (7) the secretary for children and families or the secretary's designee;

11 (8) the commissioner of education or the commissioner's designee;

12 (9) the deputy secretary of juvenile services at the department of
13 corrections or the deputy's designee;

14 (10) the director of community-based services at the department of
15 corrections, or the director's designee;

16 (11) two district court judges appointed by the chief justice of the
17 supreme court;

18 (12) one chief court services officer appointed by the chief justice of
19 the supreme court;

20 (13) one member of the office of judicial administration appointed by
21 the chief justice of the supreme court;

22 (14) one juvenile defense attorney appointed by the chief justice of
23 the supreme court;

24 (15) one juvenile crime victim advocate appointed by the governor;

25 (16) one member from a ~~state~~ *local* law enforcement agency
26 appointed by the governor; and

27 (17) one member from a prosecuting attorney's office appointed by
28 the governor; *and*

29 ***(18) one member from a community corrections agency appointed***
30 ***by the governor.***

31 (c) The committee shall be appointed by January 1, 2017, and shall
32 meet within 90 days after appointment and at least quarterly thereafter,
33 upon notice by the chair. The committee shall select a chairperson and
34 vice-chairperson, and 10 members shall be considered a quorum.

35 (d) The committee shall perform the following duties:

36 (1) Guide and evaluate the implementation of the changes in law
37 relating to juvenile justice reform;

38 (2) define performance measures and recidivism;

39 (3) approve a plan developed by court services and the department of
40 corrections instituting a uniform process for collecting and reviewing
41 performance measures and recidivism, costs and outcomes of programs;

42 (4) consider utilizing the Kansas criminal justice information system
43 for data collection and analyses;

- 1 (5) ensure system integration and accountability;
- 2 (6) monitor the fidelity of implementation efforts to programs and
3 training efforts;
- 4 (7) calculate any state expenditures that have been avoided by
5 reductions in the number of youth placed in out-of-home placements to
6 recommend to the governor and the legislature reinvestment of funds into:
- 7 (A) Evidence-based practices and programs in the community
8 pursuant to K.S.A. 2015 Supp. 38-2302, and amendments thereto, for use
9 by intake and assessment services, immediate intervention, probation and
10 conditional release; and
- 11 (B) training on evidence-based practices for juvenile justice system
12 staff, including, but not limited to, training in cognitive behavioral
13 therapies, family-centered therapies, substance abuse, sex offender therapy
14 and other services that address a juvenile's risks and needs; *and*
- 15 ***(C) monitor the plan from the department of corrections for the***
16 ***prioritization of funds pursuant to section 13(d), and amendments***
17 ***thereto.***
- 18 (8) continue to review any additional topics relating to the continued
19 improvement of the juvenile justice system, including:
- 20 (A) The confidentiality of juvenile records;
- 21 (B) the reduction of the financial burden placed on families involved
22 in the juvenile justice system;
- 23 ~~(C) juvenile due process rights, including, but not limited to, the~~
24 ~~development of rights to a speedy trial and preliminary hearings;~~
- 25 ~~(D)~~ the improvement of conditions of confinement for juveniles; and
- 26 ~~(E)~~**(D)** the removal from the home of children in need of care for
27 non-abuse or neglect, truancy, running away or additional child behavior
28 problems when there is no court finding of parental abuse or neglect; and
- 29 (9) adhere to the goals of the juvenile justice code as provided in
30 K.S.A. 2015 Supp. 38-2301, and amendments thereto.
- 31 (e) The committee shall issue an annual report to the governor, the
32 president of the senate, the speaker of the house of representatives and the
33 chief justice of the supreme court on or before November 30th each year
34 starting in 2017. Such report shall include:
- 35 (1) An assessment of the progress made in implementation of
36 juvenile justice reform efforts;
- 37 (2) a summary of the committee's efforts in fulfilling its duties as set
38 forth in this section;
- 39 (3) an analysis of the recidivism data obtained by the committee
40 pursuant to this section;
- 41 (4) a summary of the averted costs calculated by the committee
42 pursuant to this section and a recommendation for any reinvestment of the
43 averted costs to fund services or programs to expand Kansas' continuum of

1 alternatives for juveniles who would otherwise be placed in out-of-home
2 placements;

3 (5) an analysis of detention risk-assessment data to determine if any
4 disparate impacts resulted at any stage of the juvenile justice system based
5 on race, sex, national origin or economic status; and

6 (6) recommendations for continued improvements to the juvenile
7 justice system.

8 (f) After initial appointment, members appointed to this committee by
9 the governor, the president of the senate, the speaker of the house of
10 representatives or the chief justice of the supreme court pursuant to
11 subsection (b), shall serve for a term of two years and shall be eligible for
12 reappointment to such position. All members appointed to the committee
13 shall serve until a successor has been duly appointed.

14 New Sec. 5. (a) Training on evidence-based programs and practices
15 shall be mandatory for all individuals who work with juveniles adjudicated
16 or participating in an immediate intervention under the Kansas revised
17 juvenile justice code. Such individuals shall include, but not be limited to:

18 (1) Community supervision officers;

19 (2) juvenile intake and assessment workers;

20 (3) juvenile corrections officers; and

21 (4) any individual who works with juveniles through a contracted
22 organization providing services to juveniles.

23 (b) The department of corrections, in conjunction with the office of
24 judicial administration shall provide training in evidence-based programs
25 and practices on *not less than* a semi-annual basis to those required to
26 receive such training pursuant to subsection (a).

27 ~~New Sec. 6. The chief justice of the supreme court shall designate an
28 individual or create a statewide entity to oversee all attorneys appointed to
29 represent juveniles pursuant to K.S.A. 2015 Supp. 38-2306(a), and
30 amendments thereto.~~

31 ~~New Sec. 7. 6.~~ (a) The department of corrections, in collaboration
32 with the office of judicial administration, shall develop standards and
33 procedures to guide the administration of an immediate intervention
34 process and programs developed pursuant to K.S.A. 2015 Supp. 38-2346,
35 and amendments thereto, and alternative means of adjudication pursuant to
36 K.S.A. 2015 Supp. 38-2389, and amendments thereto. Such standards and
37 procedures shall include, but not be limited to:

38 (1) Contact requirements;

39 (2) parent engagement;

40 (3) graduated response and discharge requirements; and

41 (4) process and quality assurance.

42 (b) This section shall take effect on and after January 1, 2017.

43 ~~New Sec. 8. 7.~~ (a) When a juvenile is placed outside the juvenile's

1 home at a dispositional hearing pursuant to K.S.A. 2015 Supp. 38-2361(k),
2 and amendments thereto, and no reintegration plan is made a part of the
3 record of the hearing, a written reintegration plan shall be prepared and
4 submitted to the court within 15 days of the initial order of the court.

5 (b) The plan shall be prepared by the person who has custody or, if
6 directed by the court, by a community supervision officer.

7 (c) If there is a lack of agreement among persons necessary for the
8 success of the plan, the person or entity having custody of the child shall
9 notify the court, and the court shall set a hearing pursuant to K.S.A. 2015
10 Supp. 38-2367, and amendments thereto.

11 (d) This section shall be part of and supplemental to the revised
12 Kansas juvenile justice code.

13 *(e) This section shall take effect on and after July 1, 2017.*

14 New Sec.—~~9~~: **8.** For purposes of determining a release date of a
15 juvenile offender from custody of the secretary of corrections, the
16 secretary shall promulgate rules and regulations *by January 1, 2017*,
17 regarding earned time calculations.

18 New Sec.—~~10~~: **9.** For purposes of determining release of a juvenile
19 from probation, the supreme court, in consultation with the department of
20 corrections, shall establish rules for a system of earned discharge for
21 juvenile probationers to be applied by all community supervision officers.
22 A probationer shall be awarded earned discharge credits while on
23 probation for each full calendar month of compliance with terms of
24 supervised probation pursuant to the rules developed by the supreme court.

25 New Sec.—~~11~~: **10.** (a) The office of judicial administration shall
26 designate or develop a training protocol for judges, county and district
27 attorneys and defense attorneys who work in juvenile court.

28 (b) The office of judicial administration shall report annually to the
29 legislature and to the juvenile justice oversight committee established
30 pursuant to section 4, and amendments thereto, data pertaining to the
31 completion of the training protocol, including, but not limited to, the
32 number of judges, district and county attorneys and defense attorneys who
33 did and did not complete the training protocol.

34 New Sec.—~~12~~: **11.** (a) The department of corrections shall create a plan
35 and provide funding to incentivize the development of immediate
36 intervention programs established pursuant to K.S.A. 2015 Supp. 38-2346,
37 and amendments thereto.

38 (b) Funds allocated in accordance with such plan shall be used only
39 for the purpose of making grants to immediate intervention programs that
40 adhere to the standards and procedures for such programs developed
41 pursuant to section—~~7~~ **6**, and amendments thereto, and shall be based on the
42 number of persons served and such other requirements as may be
43 established by the department of corrections. The plan may include

1 requirements for grant applications, organizational characteristics,
2 reporting and auditing criteria and such other standards for eligibility and
3 accountability.

4 (c) This section shall take effect on and after January 1, 2017.

5 ~~New Sec. 13.~~ **12.** The department of corrections shall develop for use
6 by the courts pursuant to K.S.A. 2015 Supp. 38-2367(d), and amendments
7 thereto, community integration programs for juveniles who are ready to
8 transition to independent living. Community integration programs shall be
9 designed to prepare juveniles to become socially and financially
10 independent from the program.

11 ~~New Sec. 14.~~ **13.** (a) There is hereby established in the state treasury
12 the Kansas juvenile justice improvement fund, which shall be administered
13 by the department of corrections. All expenditures from the Kansas
14 juvenile justice improvement fund shall be for the development and
15 implementation of evidence-based community programs and practices for
16 juvenile offenders and their families by community supervision offices,
17 including, but not limited to, juvenile intake and assessment, court services
18 and community corrections. All expenditures from the Kansas juvenile
19 justice improvement fund shall be made in accordance with appropriation
20 acts upon warrants of the director of accounts and reports issued pursuant
21 to vouchers approved by the secretary of corrections or the secretary's
22 designee.

23 (b) Annually, on or before June 30, the secretary of corrections shall
24 determine and certify to the director of accounts and reports the amount in
25 each account of the state general fund of a state agency that has been
26 determined by the secretary to be actual or projected cost savings as a
27 result of cost avoidance resulting from decreased reliance on incarceration
28 in the juvenile correctional facility and placement in youth residential
29 centers. ***The baseline shall be calculated on the cost of incarceration and***
30 ***placement in fiscal year 2015.***

31 (c) Annually, on July 1 or as soon thereafter as moneys are available,
32 the director of accounts and reports shall transfer the amount certified
33 pursuant to subsection (b) from each account of the state general fund of a
34 state agency that has been determined by the secretary of corrections to be
35 actual or projected cost savings to the Kansas juvenile justice
36 improvement fund.

37 ***(d) Prioritization of funds will be given to regions that demonstrate***
38 ***a high rate of out-of-home placement of juvenile offenders per capita***
39 ***that have few existing community-based alternatives.***

40 ***(e) During fiscal years 2017 and 2018, the secretary of corrections***
41 ***shall transfer an amount not to exceed \$8,000,000 from appropriated***
42 ***moneys from any available special revenue fund or funds that are***
43 ***budgeted for the purposes of facilitating the development and***

1 ***implementation of new community placements in conjunction with the***
2 ***reduction in out-of-home placements.***

3 New Sec. ~~15~~. 14. (a) The attorney general shall, in collaboration with
4 the Kansas law enforcement training center and the state board of
5 education, promulgate rules and regulations ***by January 1, 2017***, creating a
6 skill development training for responding effectively to misconduct in
7 school while minimizing student exposure to the juvenile justice system.

8 (b) The skill development training shall include, but not be limited to,
9 the following:

- 10 (1) Information on adolescent development;
- 11 (2) risk and needs assessments;
- 12 (3) mental health;
- 13 (4) diversity;
- 14 (5) youth crisis intervention;
- 15 (6) substance abuse prevention;
- 16 (7) trauma-informed responses; and
- 17 (8) other evidence-based practices in school policing to mitigate
18 student juvenile justice exposure.

19 (c) The superintendent of each school district or the superintendent's
20 designee and any law enforcement officer primarily assigned to a school
21 shall complete the skill development training.

22 ***New Sec. 15. Juveniles who are alleged to be juvenile offenders***
23 ***shall have a right to a speedy trial and a right to a preliminary hearing.***

24 ***New Sec. 16. The department of corrections and the Kansas***
25 ***juvenile justice oversight committee shall explore methods of***
26 ***exchanging confidential data between all parts of the juvenile justice***
27 ***system. Such data exchange shall be limited based on the needs of the***
28 ***user accessing the data. Such method of exchanging data shall take into***
29 ***consideration sharing data that is necessary for continuity of treatment***
30 ***and correctional programs, including, but not limited to, health care***
31 ***requirements, mental health care needs and history, substance abuse***
32 ***treatment and history, recommendations for emergency placement***
33 ***options and any other information to assist in providing proper care to***
34 ***the juvenile. Such data exchange will be controlled utilizing the Kansas***
35 ***criminal justice information system. The department of corrections is***
36 ***authorized to use grant funds, allocated state funds or any other***
37 ***accessible funding necessary to create such data exchange system. All***
38 ***state and local programs involved in the care of juveniles involved in the***
39 ***juvenile justice system or the child in need of care system shall cooperate***
40 ***in the development and utilization of such system.***

41 ~~Sec. 16~~. 17. K.S.A. 2015 Supp. 8-241 is hereby amended to read as
42 follows: 8-241. (a) Except as provided in K.S.A. 8-2,125 through 8-2,142,
43 and amendments thereto, any person licensed to operate a motor vehicle in

1 this state shall submit to an examination whenever: (1) The division of
2 vehicles has good cause to believe that such person is incompetent or
3 otherwise not qualified to be licensed; or (2) the division of vehicles has
4 suspended such person's license pursuant to K.S.A. 8-1014, and
5 amendments thereto, as the result of a test refusal, test failure or conviction
6 for a violation of K.S.A. 8-1567, and amendments thereto, or a violation of
7 a city ordinance or county resolution prohibiting the acts prohibited by

15 (5) any pupil who has been tried and convicted as an adult of any
16 felony, except any pupil convicted of a felony theft crime involving no

32 to administer the juvenile intake and assessment system and programs
33 concerning juvenile offenders, the supreme court administrative orders
34 shall be in force until such contract ends and the rules and regulations
35 concerning juvenile intake and assessment system and programs
36 concerning juvenile offenders have been adopted.

37 (b) No records, reports and information obtained as a part of the
38 juvenile intake and assessment process may be admitted into evidence in
39 any proceeding and may not be used in a child in need of care proceeding

27 (7) medical history; and

29 (e) After completion of the intake and assessment process for such
30 child, the intake and assessment worker ~~may~~ *shall make both a release*
31 *and a referral determination*:

32 (1) Release the child to the custody of the child's parent, other legal
33 guardian or another appropriate adult ~~if the intake and assessment worker~~
34 ~~believes that it would be in the best interest of the child and it would not~~
35 ~~be harmful to the child to do so~~.

36 (2) Conditionally release the child to the child's parent, other legal
37 guardian or another appropriate adult if the intake and assessment worker
38 believes that if the conditions are met, it would be in the child's best
39 interest to release the child to such child's parent, other legal guardian or
40 another appropriate adult; and the intake and assessment worker has
41 reason to believe that it might be harmful to the child to release the child to
42 such child's parents, other legal guardian or another appropriate adult
43 without imposing the conditions. The conditions may include, but not be
