1 AN ACT concerning taxation; relating to the community improvement
2 district sales tax administration fund; electronic cigarettes; sales tax
3 exemptions, Gove county healthcare endowment foundation, inc.;
4 amending K.S.A. 2015 Supp. 12-6a31, 79-3399 and 79-3606 and
5 repealing the existing sections.

7 *Be it enacted by the Legislature of the State of Kansas:*

8 Section 1. K.S.A. 2015 Supp. 12-6a31 is hereby amended to read as
9 follows: 12-6a31. (a) In addition to and notwithstanding any limitations on
10 the aggregate amount of the retailers' sales tax contained in K.S.A. 12-187
11 through 12-197, and amendments thereto, any municipality may impose a
12 community improvement district sales tax on the selling of tangible
13 personal property at retail or rendering or furnishing services taxable
14 pursuant to the provisions of the Kansas retailers' sales tax act, and
15 amendments thereto, within a community improvement district for
16 purposes of financing a project in such district in any increment of .10% or
17 .25% not to exceed 2% and pledging the revenue received therefrom to
18 pay the bonds issued for the project or to reimburse the cost of the project
19 pursuant to pay-as-you-go financing. In the event bonds are issued to
20 finance a project or refunding bonds issued therefore, the community
21 improvement district sales tax imposed pursuant to this section shall expire
22 no later than the date such bonds shall mature. In the event pay-as-you-go
23 financing is utilized, the community improvement district sales tax shall
24 expire 22 years from the date the state director of taxation begins
25 collecting such tax or when the project bonds or pay-as-you-go costs have
26 been paid. Except as otherwise provided by the provisions of K.S.A. 2015
27 Supp. 12-6a27 et seq., and amendments thereto, the tax authorized by this
28 section shall be administered, collected and subject to the provisions of
29 K.S.A. 12-187 through 12-197, inclusive, and amendments thereto.

30 (b) Upon receipt of a certified copy of the resolution or ordinance
31 authorizing the levy of the community improvement district sales tax
32 pursuant to this section, the state director of taxation shall cause such tax
33 to be collected in the district at the same time and in the same manner
34 provided for the collection of the state retailers' sales tax. All of the taxes
35 collected under the provisions of this act shall be remitted by the secretary
36 of revenue to the state treasurer in accordance with the provisions of

1 K.S.A. 75-4215, and amendments thereto. Upon receipt of each such
2 remittance, the state treasurer shall deposit the entire amount in the state
3 treasury, and the state treasurer shall credit 2% of all taxes so collected to
4 the community improvement district sales tax administration fund, which
5 fund is hereby established in the state treasury, to defray the expenses of
6 the department of revenue in administration and enforcement of the
7 collection thereof. The aggregate amount of moneys credited to the
8 community improvement district sales tax administration fund shall not
9 exceed ~~\$60,000~~ \$200,000 in any state fiscal year. The remainder of such
10 taxes shall be credited to the community improvement district sales tax
11 fund, which fund is hereby established in the state treasury. All moneys in
12 the community improvement district sales tax fund shall be remitted at
13 least quarterly by the state treasurer, on instruction from the secretary of
14 revenue, to the treasurers of those municipalities which are qualified to
15 receive disbursements from such fund for the amount collected within
16 such municipality. Any refund due on any community improvement
17 district sales tax collected pursuant to this section shall be paid out of the
18 community improvement district sales tax refund fund which is hereby
19 established in the state treasury and reimbursed by the director of taxation
20 from collections of the community improvement district sales tax
21 authorized by this section. Community improvement district sales tax
22 received by a municipality pursuant to this section shall be deposited in the
23 community improvement district sales tax fund created pursuant to K.S.A.
24 2015 Supp. 12-6a34, and amendments thereto.

25 (c) Notwithstanding any other provisions of law to the contrary,
26 copies of all retailers' sales and use tax returns filed with the secretary of
27 revenue in connection with a district for which sales or use tax revenues,
28 or both, are pledged or otherwise intended to be used in whole or in part
29 for the payment of bonds issued to finance costs of a project, shall be
30 provided by the secretary of revenue to the bond trustee, escrow agent or
31 paying agent for such bonds upon a written request of the municipality
32 within 15 days of receipt by the secretary of revenue. The bond trustee,
33 escrow agent or paying agent shall keep such retailers' sales and use tax
34 returns and the information contained therein confidential, but may use
35 such information for purposes of allocating and depositing such sales and
36 use tax revenues in connection with the bonds used to finance costs of a
37 project. Except as otherwise provided herein, the sales and use tax returns
38 received by the bond trustee, escrow agent or paying agent shall be subject
39 to the provisions of K.S.A. 79-3614, and amendments thereto.

40 Sec. 2. K.S.A. 2015 Supp. 79-3399 is hereby amended to read as
41 follows: 79-3399. (a) On and after ~~July 1, 2016~~ *January 1, 2017*, a tax is
42 hereby imposed upon the privilege of selling or dealing in electronic
43 cigarettes in this state by any person engaged in business as a distributor

1 thereof, at the rate of \$.20 per milliliter of consumable material for
2 electronic cigarettes and a proportionate tax at the like rate on all fractional
3 parts thereof. For electronic cigarettes in the possession of retail dealers
4 for which tax has not been paid, tax shall be imposed under this subsection
5 at the earliest time the retail dealer: (1) Brings or causes to be brought into
6 this state from without the state electronic cigarettes for sale; (2) makes,
7 manufactures or fabricates electronic cigarettes in this state for sale in this
8 state; or (3) sells electronic cigarettes to consumers within this state.

9 (b) The secretary of revenue shall adopt rules and regulations to
10 implement the provisions of this section.

11 Sec. 3. Section 1. K.S.A. 2015 Supp. 79-3606 is hereby amended to
12 read as follows: 79-3606. The following shall be exempt from the tax
13 imposed by this act:

14 (a) All sales of motor-vehicle fuel or other articles upon which a sales
15 or excise tax has been paid, not subject to refund, under the laws of this
16 state except cigarettes and electronic cigarettes as defined by K.S.A. 79-
17 3301, and amendments thereto, including consumable material for such
18 electronic cigarettes, cereal malt beverages and malt products as defined
19 by K.S.A. 79-3817, and amendments thereto, including wort, liquid malt,
20 malt syrup and malt extract, which is not subject to taxation under the
21 provisions of K.S.A. 79-41a02, and amendments thereto, motor vehicles
22 taxed pursuant to K.S.A. 79-5117, and amendments thereto, tires taxed
23 pursuant to K.S.A. 65-3424d, and amendments thereto, drycleaning and
24 laundry services taxed pursuant to K.S.A. 65-34,150, and amendments
25 thereto, and gross receipts from regulated sports contests taxed pursuant to
26 the Kansas professional regulated sports act, and amendments thereto;

27 (b) all sales of tangible personal property or service, including the
28 renting and leasing of tangible personal property, purchased directly by the
29 state of Kansas, a political subdivision thereof, other than a school or
30 educational institution, or purchased by a public or private nonprofit
31 hospital or public hospital authority or nonprofit blood, tissue or organ
32 bank and used exclusively for state, political subdivision, hospital or
33 public hospital authority or nonprofit blood, tissue or organ bank purposes,
34 except when: (1) Such state, hospital or public hospital authority is
35 engaged or proposes to engage in any business specifically taxable under
36 the provisions of this act and such items of tangible personal property or
37 service are used or proposed to be used in such business; or (2) such
38 political subdivision is engaged or proposes to engage in the business of
39 furnishing gas, electricity or heat to others and such items of personal
40 property or service are used or proposed to be used in such business;

41 (c) all sales of tangible personal property or services, including the
42 renting and leasing of tangible personal property, purchased directly by a
43 public or private elementary or secondary school or public or private

1 nonprofit educational institution and used primarily by such school or
2 institution for nonsectarian programs and activities provided or sponsored
3 by such school or institution or in the erection, repair or enlargement of
4 buildings to be used for such purposes. The exemption herein provided
5 shall not apply to erection, construction, repair, enlargement or equipment
6 of buildings used primarily for human habitation;

7 (d) all sales of tangible personal property or services purchased by a
8 contractor for the purpose of constructing, equipping, reconstructing,
9 maintaining, repairing, enlarging, furnishing or remodeling facilities for
10 any public or private nonprofit hospital or public hospital authority, public
11 or private elementary or secondary school, a public or private nonprofit
12 educational institution, state correctional institution including a privately
13 constructed correctional institution contracted for state use and ownership,
14 which would be exempt from taxation under the provisions of this act if
15 purchased directly by such hospital or public hospital authority, school,
16 educational institution or a state correctional institution; and all sales of
17 tangible personal property or services purchased by a contractor for the
18 purpose of constructing, equipping, reconstructing, maintaining, repairing,
19 enlarging, furnishing or remodeling facilities for any political subdivision
20 of the state or district described in subsection (s), the total cost of which is
21 paid from funds of such political subdivision or district and which would
22 be exempt from taxation under the provisions of this act if purchased
23 directly by such political subdivision or district. Nothing in this subsection
24 or in the provisions of K.S.A. 12-3418, and amendments thereto, shall be
25 deemed to exempt the purchase of any construction machinery, equipment
26 or tools used in the constructing, equipping, reconstructing, maintaining,
27 repairing, enlarging, furnishing or remodeling facilities for any political
28 subdivision of the state or any such district. As used in this subsection,
29 K.S.A. 12-3418 and 79-3640, and amendments thereto, "funds of a
30 political subdivision" shall mean general tax revenues, the proceeds of any
31 bonds and gifts or grants-in-aid. Gifts shall not mean funds used for the
32 purpose of constructing, equipping, reconstructing, repairing, enlarging,
33 furnishing or remodeling facilities which are to be leased to the donor.
34 When any political subdivision of the state, district described in subsection
35 (s), public or private nonprofit hospital or public hospital authority, public
36 or private elementary or secondary school, public or private nonprofit
37 educational institution, state correctional institution including a privately
38 constructed correctional institution contracted for state use and ownership
39 shall contract for the purpose of constructing, equipping, reconstructing,
40 maintaining, repairing, enlarging, furnishing or remodeling facilities, it
41 shall obtain from the state and furnish to the contractor an exemption
42 certificate for the project involved, and the contractor may purchase
43 materials for incorporation in such project. The contractor shall furnish the

1 number of such certificate to all suppliers from whom such purchases are
2 made, and such suppliers shall execute invoices covering the same bearing
3 the number of such certificate. Upon completion of the project the
4 contractor shall furnish to the political subdivision, district described in
5 subsection (s), hospital or public hospital authority, school, educational
6 institution or department of corrections concerned a sworn statement, on a
7 form to be provided by the director of taxation, that all purchases so made
8 were entitled to exemption under this subsection. As an alternative to the
9 foregoing procedure, any such contracting entity may apply to the
10 secretary of revenue for agent status for the sole purpose of issuing and
11 furnishing project exemption certificates to contractors pursuant to rules
12 and regulations adopted by the secretary establishing conditions and
13 standards for the granting and maintaining of such status. All invoices
14 shall be held by the contractor for a period of five years and shall be
15 subject to audit by the director of taxation. If any materials purchased
16 under such a certificate are found not to have been incorporated in the
17 building or other project or not to have been returned for credit or the sales
18 or compensating tax otherwise imposed upon such materials which will
19 not be so incorporated in the building or other project reported and paid by
20 such contractor to the director of taxation not later than the 20th day of the
21 month following the close of the month in which it shall be determined
22 that such materials will not be used for the purpose for which such
23 certificate was issued, the political subdivision, district described in
24 subsection (s), hospital or public hospital authority, school, educational
25 institution or the contractor contracting with the department of corrections
26 for a correctional institution concerned shall be liable for tax on all
27 materials purchased for the project, and upon payment thereof it may
28 recover the same from the contractor together with reasonable attorney
29 fees. Any contractor or any agent, employee or subcontractor thereof, who
30 shall use or otherwise dispose of any materials purchased under such a
31 certificate for any purpose other than that for which such a certificate is
32 issued without the payment of the sales or compensating tax otherwise
33 imposed upon such materials, shall be guilty of a misdemeanor and, upon
34 conviction therefor, shall be subject to the penalties provided for in K.S.A.
35 79-3615(h), and amendments thereto;

36 (e) all sales of tangible personal property or services purchased by a
37 contractor for the erection, repair or enlargement of buildings or other
38 projects for the government of the United States, its agencies or
39 instrumentalities, which would be exempt from taxation if purchased
40 directly by the government of the United States, its agencies or
41 instrumentalities. When the government of the United States, its agencies
42 or instrumentalities shall contract for the erection, repair, or enlargement
43 of any building or other project, it shall obtain from the state and furnish to

1 the contractor an exemption certificate for the project involved, and the
2 contractor may purchase materials for incorporation in such project. The
3 contractor shall furnish the number of such certificates to all suppliers
4 from whom such purchases are made, and such suppliers shall execute
5 invoices covering the same bearing the number of such certificate. Upon
6 completion of the project the contractor shall furnish to the government of
7 the United States, its agencies or instrumentalities concerned a sworn
8 statement, on a form to be provided by the director of taxation, that all
9 purchases so made were entitled to exemption under this subsection. As an
10 alternative to the foregoing procedure, any such contracting entity may
11 apply to the secretary of revenue for agent status for the sole purpose of
12 issuing and furnishing project exemption certificates to contractors
13 pursuant to rules and regulations adopted by the secretary establishing
14 conditions and standards for the granting and maintaining of such status.
15 All invoices shall be held by the contractor for a period of five years and
16 shall be subject to audit by the director of taxation. Any contractor or any
17 agent, employee or subcontractor thereof, who shall use or otherwise
18 dispose of any materials purchased under such a certificate for any purpose
19 other than that for which such a certificate is issued without the payment
20 of the sales or compensating tax otherwise imposed upon such materials,
21 shall be guilty of a misdemeanor and, upon conviction therefor, shall be
22 subject to the penalties provided for in K.S.A. 79-3615(h), and
23 amendments thereto;

24 (f) tangible personal property purchased by a railroad or public utility
25 for consumption or movement directly and immediately in interstate
26 commerce;

27 (g) sales of aircraft including remanufactured and modified aircraft
28 sold to persons using directly or through an authorized agent such aircraft
29 as certified or licensed carriers of persons or property in interstate or
30 foreign commerce under authority of the laws of the United States or any
31 foreign government or sold to any foreign government or agency or
32 instrumentality of such foreign government and all sales of aircraft for use
33 outside of the United States and sales of aircraft repair, modification and
34 replacement parts and sales of services employed in the remanufacture,
35 modification and repair of aircraft;

36 (h) all rentals of nonsectarian textbooks by public or private
37 elementary or secondary schools;

38 (i) the lease or rental of all films, records, tapes, or any type of sound
39 or picture transcriptions used by motion picture exhibitors;

40 (j) meals served without charge or food used in the preparation of
41 such meals to employees of any restaurant, eating house, dining car, hotel,
42 drugstore or other place where meals or drinks are regularly sold to the
43 public if such employees' duties are related to the furnishing or sale of

1 such meals or drinks;

2 (k) any motor vehicle, semitrailer or pole trailer, as such terms are
3 defined by K.S.A. 8-126, and amendments thereto, or aircraft sold and
4 delivered in this state to a bona fide resident of another state, which motor
5 vehicle, semitrailer, pole trailer or aircraft is not to be registered or based
6 in this state and which vehicle, semitrailer, pole trailer or aircraft will not
7 remain in this state more than 10 days;

8 (l) all isolated or occasional sales of tangible personal property,
9 services, substances or things, except isolated or occasional sale of motor
10 vehicles specifically taxed under the provisions of K.S.A. 79-3603(o), and
11 amendments thereto;

12 (m) all sales of tangible personal property which become an
13 ingredient or component part of tangible personal property or services
14 produced, manufactured or compounded for ultimate sale at retail within
15 or without the state of Kansas; and any such producer, manufacturer or
16 compounder may obtain from the director of taxation and furnish to the
17 supplier an exemption certificate number for tangible personal property for
18 use as an ingredient or component part of the property or services
19 produced, manufactured or compounded;

20 (n) all sales of tangible personal property which is consumed in the
21 production, manufacture, processing, mining, drilling, refining or
22 compounding of tangible personal property, the treating of by-products or
23 wastes derived from any such production process, the providing of
24 services or the irrigation of crops for ultimate sale at retail within or
25 without the state of Kansas; and any purchaser of such property may
26 obtain from the director of taxation and furnish to the supplier an
27 exemption certificate number for tangible personal property for
28 consumption in such production, manufacture, processing, mining,
29 drilling, refining, compounding, treating, irrigation and in providing such
30 services;

31 (o) all sales of animals, fowl and aquatic plants and animals, the
32 primary purpose of which is use in agriculture or aquaculture, as defined in
33 K.S.A. 47-1901, and amendments thereto, the production of food for
34 human consumption, the production of animal, dairy, poultry or aquatic
35 plant and animal products, fiber or fur, or the production of offspring for
36 use for any such purpose or purposes;

37 (p) all sales of drugs dispensed pursuant to a prescription order by a
38 licensed practitioner or a mid-level practitioner as defined by K.S.A. 65-
39 1626, and amendments thereto. As used in this subsection, "drug" means a
40 compound, substance or preparation and any component of a compound,
41 substance or preparation, other than food and food ingredients, dietary
42 supplements or alcoholic beverages, recognized in the official United
43 States pharmacopoeia, official homeopathic pharmacopoeia of the United

1 States or official national formulary, and supplement to any of them,
2 intended for use in the diagnosis, cure, mitigation, treatment or prevention
3 of disease or intended to affect the structure or any function of the body,
4 except that for taxable years commencing after December 31, 2013, this
5 subsection shall not apply to any sales of drugs used in the performance or
6 induction of an abortion, as defined in K.S.A. 65-6701, and amendments
7 thereto;

8 (q) all sales of insulin dispensed by a person licensed by the state
9 board of pharmacy to a person for treatment of diabetes at the direction of
10 a person licensed to practice medicine by the board of healing arts;

11 (r) all sales of oxygen delivery equipment, kidney dialysis equipment,
12 enteral feeding systems, prosthetic devices and mobility enhancing
13 equipment prescribed in writing by a person licensed to practice the
14 healing arts, dentistry or optometry, and in addition to such sales, all sales
15 of hearing aids, as defined by K.S.A. 74-5807(c), and amendments thereto,
16 and repair and replacement parts therefor, including batteries, by a person
17 licensed in the practice of dispensing and fitting hearing aids pursuant to
18 the provisions of K.S.A. 74-5808, and amendments thereto. For the
19 purposes of this subsection: (1) "Mobility enhancing equipment" means
20 equipment including repair and replacement parts to same, but does not
21 include durable medical equipment, which is primarily and customarily
22 used to provide or increase the ability to move from one place to another
23 and which is appropriate for use either in a home or a motor vehicle; is not
24 generally used by persons with normal mobility; and does not include any
25 motor vehicle or equipment on a motor vehicle normally provided by a
26 motor vehicle manufacturer; and (2) "prosthetic device" means a
27 replacement, corrective or supportive device including repair and
28 replacement parts for same worn on or in the body to artificially replace a
29 missing portion of the body, prevent or correct physical deformity or
30 malfunction or support a weak or deformed portion of the body;

31 (s) except as provided in K.S.A. 2015 Supp. 82a-2101, and
32 amendments thereto, all sales of tangible personal property or services
33 purchased directly or indirectly by a groundwater management district
34 organized or operating under the authority of K.S.A. 82a-1020 et seq., and
35 amendments thereto, by a rural water district organized or operating under
36 the authority of K.S.A. 82a-612, and amendments thereto, or by a water
37 supply district organized or operating under the authority of K.S.A. 19-
38 3501 et seq., 19-3522 et seq., or 19-3545, and amendments thereto, which
39 property or services are used in the construction activities, operation or
40 maintenance of the district;

41 (t) all sales of farm machinery and equipment or aquaculture
42 machinery and equipment, repair and replacement parts therefor and
43 services performed in the repair and maintenance of such machinery and

1 equipment. For the purposes of this subsection the term "farm machinery
2 and equipment or aquaculture machinery and equipment" shall include a
3 work-site utility vehicle, as defined in K.S.A. 8-126, and amendments
4 thereto, and is equipped with a bed or cargo box for hauling materials, and
5 shall also include machinery and equipment used in the operation of
6 Christmas tree farming but shall not include any passenger vehicle, truck,
7 truck tractor, trailer, semitrailer or pole trailer, other than a farm trailer, as
8 such terms are defined by K.S.A. 8-126, and amendments thereto. "Farm
9 machinery and equipment" includes precision farming equipment that is
10 portable or is installed or purchased to be installed on farm machinery and
11 equipment. "Precision farming equipment" includes the following items
12 used only in computer-assisted farming, ranching or aquaculture
13 production operations: Soil testing sensors, yield monitors, computers,
14 monitors, software, global positioning and mapping systems, guiding
15 systems, modems, data communications equipment and any necessary
16 mounting hardware, wiring and antennas. Each purchaser of farm
17 machinery and equipment or aquaculture machinery and equipment
18 exempted herein must certify in writing on the copy of the invoice or sales
19 ticket to be retained by the seller that the farm machinery and equipment
20 or aquaculture machinery and equipment purchased will be used only in
21 farming, ranching or aquaculture production. Farming or ranching shall
22 include the operation of a feedlot and farm and ranch work for hire and the
23 operation of a nursery;

24 (u) all leases or rentals of tangible personal property used as a
25 dwelling if such tangible personal property is leased or rented for a period
26 of more than 28 consecutive days;

27 (v) all sales of tangible personal property to any contractor for use in
28 preparing meals for delivery to homebound elderly persons over 60 years
29 of age and to homebound disabled persons or to be served at a group-
30 sitting at a location outside of the home to otherwise homebound elderly
31 persons over 60 years of age and to otherwise homebound disabled
32 persons, as all or part of any food service project funded in whole or in
33 part by government or as part of a private nonprofit food service project
34 available to all such elderly or disabled persons residing within an area of
35 service designated by the private nonprofit organization, and all sales of
36 tangible personal property for use in preparing meals for consumption by
37 indigent or homeless individuals whether or not such meals are consumed
38 at a place designated for such purpose, and all sales of food products by or
39 on behalf of any such contractor or organization for any such purpose;

40 (w) all sales of natural gas, electricity, heat and water delivered
41 through mains, lines or pipes: (1) To residential premises for
42 noncommercial use by the occupant of such premises; (2) for agricultural
43 use and also, for such use, all sales of propane gas; (3) for use in the

1 severing of oil; and (4) to any property which is exempt from property
2 taxation pursuant to K.S.A. 79-201b, *Second* through *Sixth*. As used in this
3 paragraph, "severing" shall have the meaning ascribed thereto by K.S.A.
4 79-4216(k), and amendments thereto. For all sales of natural gas,
5 electricity and heat delivered through mains, lines or pipes pursuant to the
6 provisions of subsection (w)(1) and (w)(2), the provisions of this
7 subsection shall expire on December 31, 2005;

8 (x) all sales of propane gas, LP-gas, coal, wood and other fuel sources
9 for the production of heat or lighting for noncommercial use of an
10 occupant of residential premises occurring prior to January 1, 2006;

11 (y) all sales of materials and services used in the repairing, servicing,
12 altering, maintaining, manufacturing, remanufacturing, or modification of
13 railroad rolling stock for use in interstate or foreign commerce under
14 authority of the laws of the United States;

15 (z) all sales of tangible personal property and services purchased
16 directly by a port authority or by a contractor therefor as provided by the
17 provisions of K.S.A. 12-3418, and amendments thereto;

18 (aa) all sales of materials and services applied to equipment which is
19 transported into the state from without the state for repair, service,
20 alteration, maintenance, remanufacture or modification and which is
21 subsequently transported outside the state for use in the transmission of
22 liquids or natural gas by means of pipeline in interstate or foreign
23 commerce under authority of the laws of the United States;

24 (bb) all sales of used mobile homes or manufactured homes. As used
25 in this subsection: (1) "Mobile homes" and "manufactured homes" shall
26 have the meanings ascribed thereto by K.S.A. 58-4202, and amendments
27 thereto; and (2) "sales of used mobile homes or manufactured homes"
28 means sales other than the original retail sale thereof;

29 (cc) all sales of tangible personal property or services purchased prior
30 to January 1, 2012, except as otherwise provided, for the purpose of and in
31 conjunction with constructing, reconstructing, enlarging or remodeling a
32 business or retail business which meets the requirements established in
33 K.S.A. 74-50,115, and amendments thereto, and the sale and installation of
34 machinery and equipment purchased for installation at any such business
35 or retail business, and all sales of tangible personal property or services
36 purchased on or after January 1, 2012, for the purpose of and in
37 conjunction with constructing, reconstructing, enlarging or remodeling a
38 business which meets the requirements established in K.S.A. 74-50,115(e),
39 and amendments thereto, and the sale and installation of machinery and
40 equipment purchased for installation at any such business. When a person
41 shall contract for the construction, reconstruction, enlargement or
42 remodeling of any such business or retail business, such person shall
43 obtain from the state and furnish to the contractor an exemption certificate

1 for the project involved, and the contractor may purchase materials,
2 machinery and equipment for incorporation in such project. The contractor
3 shall furnish the number of such certificates to all suppliers from whom
4 such purchases are made, and such suppliers shall execute invoices
5 covering the same bearing the number of such certificate. Upon
6 completion of the project the contractor shall furnish to the owner of the
7 business or retail business a sworn statement, on a form to be provided by
8 the director of taxation, that all purchases so made were entitled to
9 exemption under this subsection. All invoices shall be held by the
10 contractor for a period of five years and shall be subject to audit by the
11 director of taxation. Any contractor or any agent, employee or
12 subcontractor thereof, who shall use or otherwise dispose of any materials,
13 machinery or equipment purchased under such a certificate for any
14 purpose other than that for which such a certificate is issued without the
15 payment of the sales or compensating tax otherwise imposed thereon, shall
16 be guilty of a misdemeanor and, upon conviction therefor, shall be subject
17 to the penalties provided for in K.S.A. 79-3615(h), and amendments
18 thereto. As used in this subsection, "business" and "retail business" have
19 the meanings respectively ascribed thereto by K.S.A. 74-50,114, and
20 amendments thereto. Project exemption certificates that have been
21 previously issued under this subsection by the department of revenue
22 pursuant to K.S.A. 74-50,115, and amendments thereto, but not including
23 K.S.A. 74-50,115(e), and amendments thereto, prior to January 1, 2012,
24 and have not expired will be effective for the term of the project or two
25 years from the effective date of the certificate, whichever occurs earlier.
26 Project exemption certificates that are submitted to the department of
27 revenue prior to January 1, 2012, and are found to qualify will be issued a
28 project exemption certificate that will be effective for a two-year period or
29 for the term of the project, whichever occurs earlier;

30 (dd) all sales of tangible personal property purchased with food
31 stamps issued by the United States department of agriculture;

32 (ee) all sales of lottery tickets and shares made as part of a lottery
33 operated by the state of Kansas;

34 (ff) on and after July 1, 1988, all sales of new mobile homes or
35 manufactured homes to the extent of 40% of the gross receipts, determined
36 without regard to any trade-in allowance, received from such sale. As used
37 in this subsection, "mobile homes" and "manufactured homes" shall have
38 the meanings ascribed thereto by K.S.A. 58-4202, and amendments
39 thereto;

40 (gg) all sales of tangible personal property purchased in accordance
41 with vouchers issued pursuant to the federal special supplemental food
42 program for women, infants and children;

43 (hh) all sales of medical supplies and equipment, including durable

1 medical equipment, purchased directly by a nonprofit skilled nursing home
2 or nonprofit intermediate nursing care home, as defined by K.S.A. 39-923,
3 and amendments thereto, for the purpose of providing medical services to
4 residents thereof. This exemption shall not apply to tangible personal
5 property customarily used for human habitation purposes. As used in this
6 subsection, "durable medical equipment" means equipment including
7 repair and replacement parts for such equipment, which can withstand
8 repeated use, is primarily and customarily used to serve a medical purpose,
9 generally is not useful to a person in the absence of illness or injury and is
10 not worn in or on the body, but does not include mobility enhancing
11 equipment as defined in subsection (r), oxygen delivery equipment, kidney
12 dialysis equipment or enteral feeding systems;

13 (ii) all sales of tangible personal property purchased directly by a
14 nonprofit organization for nonsectarian comprehensive multidiscipline
15 youth development programs and activities provided or sponsored by such
16 organization, and all sales of tangible personal property by or on behalf of
17 any such organization. This exemption shall not apply to tangible personal
18 property customarily used for human habitation purposes;

19 (jj) all sales of tangible personal property or services, including the
20 renting and leasing of tangible personal property, purchased directly on
21 behalf of a community-based facility for people with intellectual disability
22 or mental health center organized pursuant to K.S.A. 19-4001 et seq., and
23 amendments thereto, and licensed in accordance with the provisions of
24 K.S.A. 75-3307b, and amendments thereto, and all sales of tangible
25 personal property or services purchased by contractors during the time
26 period from July, 2003, through June, 2006, for the purpose of
27 constructing, equipping, maintaining or furnishing a new facility for a
28 community-based facility for people with intellectual disability or mental
29 health center located in Riverton, Cherokee County, Kansas, which would
30 have been eligible for sales tax exemption pursuant to this subsection if
31 purchased directly by such facility or center. This exemption shall not
32 apply to tangible personal property customarily used for human habitation
33 purposes;

34 (kk) (1) (A) all sales of machinery and equipment which are used in
35 this state as an integral or essential part of an integrated production
36 operation by a manufacturing or processing plant or facility;

37 (B) all sales of installation, repair and maintenance services
38 performed on such machinery and equipment; and

39 (C) all sales of repair and replacement parts and accessories
40 purchased for such machinery and equipment.

41 (2) For purposes of this subsection:

42 (A) "Integrated production operation" means an integrated series of
43 operations engaged in at a manufacturing or processing plant or facility to

1 process, transform or convert tangible personal property by physical,
2 chemical or other means into a different form, composition or character
3 from that in which it originally existed. Integrated production operations
4 shall include: (i) Production line operations, including packaging
5 operations; (ii) preproduction operations to handle, store and treat raw
6 materials; (iii) post production handling, storage, warehousing and
7 distribution operations; and (iv) waste, pollution and environmental
8 control operations, if any;

9 (B) "production line" means the assemblage of machinery and
10 equipment at a manufacturing or processing plant or facility where the
11 actual transformation or processing of tangible personal property occurs;

12 (C) "manufacturing or processing plant or facility" means a single,
13 fixed location owned or controlled by a manufacturing or processing
14 business that consists of one or more structures or buildings in a
15 contiguous area where integrated production operations are conducted to
16 manufacture or process tangible personal property to be ultimately sold at
17 retail. Such term shall not include any facility primarily operated for the
18 purpose of conveying or assisting in the conveyance of natural gas,
19 electricity, oil or water. A business may operate one or more manufacturing
20 or processing plants or facilities at different locations to manufacture or
21 process a single product of tangible personal property to be ultimately sold
22 at retail;

23 (D) "manufacturing or processing business" means a business that
24 utilizes an integrated production operation to manufacture, process,
25 fabricate, finish, or assemble items for wholesale and retail distribution as
26 part of what is commonly regarded by the general public as an industrial
27 manufacturing or processing operation or an agricultural commodity
28 processing operation. (i) Industrial manufacturing or processing operations
29 include, by way of illustration but not of limitation, the fabrication of
30 automobiles, airplanes, machinery or transportation equipment, the
31 fabrication of metal, plastic, wood, or paper products, electricity power
32 generation, water treatment, petroleum refining, chemical production,
33 wholesale bottling, newspaper printing, ready mixed concrete production,
34 and the remanufacturing of used parts for wholesale or retail sale. Such
35 processing operations shall include operations at an oil well, gas well,
36 mine or other excavation site where the oil, gas, minerals, coal, clay, stone,
37 sand or gravel that has been extracted from the earth is cleaned, separated,
38 crushed, ground, milled, screened, washed, or otherwise treated or
39 prepared before its transmission to a refinery or before any other wholesale
40 or retail distribution. (ii) Agricultural commodity processing operations
41 include, by way of illustration but not of limitation, meat packing, poultry
42 slaughtering and dressing, processing and packaging farm and dairy
43 products in sealed containers for wholesale and retail distribution, feed

1 grinding, grain milling, frozen food processing, and grain handling,
2 cleaning, blending, fumigation, drying and aeration operations engaged in
3 by grain elevators or other grain storage facilities. (iii) Manufacturing or
4 processing businesses do not include, by way of illustration but not of
5 limitation, nonindustrial businesses whose operations are primarily retail
6 and that produce or process tangible personal property as an incidental part
7 of conducting the retail business, such as retailers who bake, cook or
8 prepare food products in the regular course of their retail trade, grocery
9 stores, meat lockers and meat markets that butcher or dress livestock or
10 poultry in the regular course of their retail trade, contractors who alter,
11 service, repair or improve real property, and retail businesses that clean,
12 service or refurbish and repair tangible personal property for its owner;

13 (E) "repair and replacement parts and accessories" means all parts
14 and accessories for exempt machinery and equipment, including, but not
15 limited to, dies, jigs, molds, patterns and safety devices that are attached to
16 exempt machinery or that are otherwise used in production, and parts and
17 accessories that require periodic replacement such as belts, drill bits,
18 grinding wheels, grinding balls, cutting bars, saws, refractory brick and
19 other refractory items for exempt kiln equipment used in production
20 operations;

21 (F) "primary" or "primarily" mean more than 50% of the time.

22 (3) For purposes of this subsection, machinery and equipment shall
23 be deemed to be used as an integral or essential part of an integrated
24 production operation when used:

25 (A) To receive, transport, convey, handle, treat or store raw materials
26 in preparation of its placement on the production line;

27 (B) to transport, convey, handle or store the property undergoing
28 manufacturing or processing at any point from the beginning of the
29 production line through any warehousing or distribution operation of the
30 final product that occurs at the plant or facility;

31 (C) to act upon, effect, promote or otherwise facilitate a physical
32 change to the property undergoing manufacturing or processing;

33 (D) to guide, control or direct the movement of property undergoing
34 manufacturing or processing;

35 (E) to test or measure raw materials, the property undergoing
36 manufacturing or processing or the finished product, as a necessary part of
37 the manufacturer's integrated production operations;

38 (F) to plan, manage, control or record the receipt and flow of
39 inventories of raw materials, consumables and component parts, the flow
40 of the property undergoing manufacturing or processing and the
41 management of inventories of the finished product;

42 (G) to produce energy for, lubricate, control the operating of or
43 otherwise enable the functioning of other production machinery and

1 equipment and the continuation of production operations;

2 (H) to package the property being manufactured or processed in a
3 container or wrapping in which such property is normally sold or
4 transported;

5 (I) to transmit or transport electricity, coke, gas, water, steam or
6 similar substances used in production operations from the point of
7 generation, if produced by the manufacturer or processor at the plant site,
8 to that manufacturer's production operation; or, if purchased or delivered
9 from off-site, from the point where the substance enters the site of the
10 plant or facility to that manufacturer's production operations;

11 (J) to cool, heat, filter, refine or otherwise treat water, steam, acid, oil,
12 solvents or other substances that are used in production operations;

13 (K) to provide and control an environment required to maintain
14 certain levels of air quality, humidity or temperature in special and limited
15 areas of the plant or facility, where such regulation of temperature or
16 humidity is part of and essential to the production process;

17 (L) to treat, transport or store waste or other byproducts of production
18 operations at the plant or facility; or

19 (M) to control pollution at the plant or facility where the pollution is
20 produced by the manufacturing or processing operation.

21 (4) The following machinery, equipment and materials shall be
22 deemed to be exempt even though it may not otherwise qualify as
23 machinery and equipment used as an integral or essential part of an
24 integrated production operation: (A) Computers and related peripheral
25 equipment that are utilized by a manufacturing or processing business for
26 engineering of the finished product or for research and development or
27 product design; (B) machinery and equipment that is utilized by a
28 manufacturing or processing business to manufacture or rebuild tangible
29 personal property that is used in manufacturing or processing operations,
30 including tools, dies, molds, forms and other parts of qualifying machinery
31 and equipment; (C) portable plants for aggregate concrete, bulk cement
32 and asphalt including cement mixing drums to be attached to a motor
33 vehicle; (D) industrial fixtures, devices, support facilities and special
34 foundations necessary for manufacturing and production operations, and
35 materials and other tangible personal property sold for the purpose of
36 fabricating such fixtures, devices, facilities and foundations. An exemption
37 certificate for such purchases shall be signed by the manufacturer or
38 processor. If the fabricator purchases such material, the fabricator shall
39 also sign the exemption certificate; (E) a manufacturing or processing
40 business' laboratory equipment that is not located at the plant or facility,
41 but that would otherwise qualify for exemption under subsection (3)(E);
42 (F) all machinery and equipment used in surface mining activities as
43 described in K.S.A. 49-601 et seq., and amendments thereto, beginning

1 from the time a reclamation plan is filed to the acceptance of the
2 completed final site reclamation.

3 (5) "Machinery and equipment used as an integral or essential part of
4 an integrated production operation" shall not include:

5 (A) Machinery and equipment used for nonproduction purposes,
6 including, but not limited to, machinery and equipment used for plant
7 security, fire prevention, first aid, accounting, administration, record
8 keeping, advertising, marketing, sales or other related activities, plant
9 cleaning, plant communications, and employee work scheduling;

10 (B) machinery, equipment and tools used primarily in maintaining
11 and repairing any type of machinery and equipment or the building and
12 plant;

13 (C) transportation, transmission and distribution equipment not
14 primarily used in a production, warehousing or material handling
15 operation at the plant or facility, including the means of conveyance of
16 natural gas, electricity, oil or water, and equipment related thereto, located
17 outside the plant or facility;

18 (D) office machines and equipment including computers and related
19 peripheral equipment not used directly and primarily to control or measure
20 the manufacturing process;

21 (E) furniture and other furnishings;

22 (F) buildings, other than exempt machinery and equipment that is
23 permanently affixed to or becomes a physical part of the building, and any
24 other part of real estate that is not otherwise exempt;

25 (G) building fixtures that are not integral to the manufacturing
26 operation, such as utility systems for heating, ventilation, air conditioning,
27 communications, plumbing or electrical;

28 (H) machinery and equipment used for general plant heating, cooling
29 and lighting;

30 (I) motor vehicles that are registered for operation on public
31 highways; or

32 (J) employee apparel, except safety and protective apparel that is
33 purchased by an employer and furnished gratuitously to employees who
34 are involved in production or research activities.

35 (6) Subsections (3) and (5) shall not be construed as exclusive listings
36 of the machinery and equipment that qualify or do not qualify as an
37 integral or essential part of an integrated production operation. When
38 machinery or equipment is used as an integral or essential part of
39 production operations part of the time and for nonproduction purposes at
40 other times, the primary use of the machinery or equipment shall
41 determine whether or not such machinery or equipment qualifies for
42 exemption.

43 (7) The secretary of revenue shall adopt rules and regulations

1 necessary to administer the provisions of this subsection;

2 (ll) all sales of educational materials purchased for distribution to the
3 public at no charge by a nonprofit corporation organized for the purpose of
4 encouraging, fostering and conducting programs for the improvement of
5 public health, except that for taxable years commencing after December
6 31, 2013, this subsection shall not apply to any sales of such materials
7 purchased by a nonprofit corporation which performs any abortion, as
8 defined in K.S.A. 65-6701, and amendments thereto;

9 (mm) all sales of seeds and tree seedlings; fertilizers, insecticides,
10 herbicides, germicides, pesticides and fungicides; and services, purchased
11 and used for the purpose of producing plants in order to prevent soil
12 erosion on land devoted to agricultural use;

13 (nn) except as otherwise provided in this act, all sales of services
14 rendered by an advertising agency or licensed broadcast station or any
15 member, agent or employee thereof;

16 (oo) all sales of tangible personal property purchased by a community
17 action group or agency for the exclusive purpose of repairing or
18 weatherizing housing occupied by low income individuals;

19 (pp) all sales of drill bits and explosives actually utilized in the
20 exploration and production of oil or gas;

21 (qq) all sales of tangible personal property and services purchased by
22 a nonprofit museum or historical society or any combination thereof,
23 including a nonprofit organization which is organized for the purpose of
24 stimulating public interest in the exploration of space by providing
25 educational information, exhibits and experiences, which is exempt from
26 federal income taxation pursuant to section 501(c)(3) of the federal
27 internal revenue code of 1986;

28 (rr) all sales of tangible personal property which will admit the
29 purchaser thereof to any annual event sponsored by a nonprofit
30 organization which is exempt from federal income taxation pursuant to
31 section 501(c)(3) of the federal internal revenue code of 1986, except that
32 for taxable years commencing after December 31, 2013, this subsection
33 shall not apply to any sales of such tangible personal property purchased
34 by a nonprofit organization which performs any abortion, as defined in
35 K.S.A. 65-6701, and amendments thereto;

36 (ss) all sales of tangible personal property and services purchased by
37 a public broadcasting station licensed by the federal communications
38 commission as a noncommercial educational television or radio station;

39 (tt) all sales of tangible personal property and services purchased by
40 or on behalf of a not-for-profit corporation which is exempt from federal
41 income taxation pursuant to section 501(c)(3) of the federal internal
42 revenue code of 1986, for the sole purpose of constructing a Kansas
43 Korean War memorial;

1 (uu) all sales of tangible personal property and services purchased by
2 or on behalf of any rural volunteer fire-fighting organization for use
3 exclusively in the performance of its duties and functions;

4 (vv) all sales of tangible personal property purchased by any of the
5 following organizations which are exempt from federal income taxation
6 pursuant to section 501(c)(3) of the federal internal revenue code of 1986,
7 for the following purposes, and all sales of any such property by or on
8 behalf of any such organization for any such purpose:

9 (1) The American heart association, Kansas affiliate, inc. for the
10 purposes of providing education, training, certification in emergency
11 cardiac care, research and other related services to reduce disability and
12 death from cardiovascular diseases and stroke;

13 (2) the Kansas alliance for the mentally ill, inc. for the purpose of
14 advocacy for persons with mental illness and to education, research and
15 support for their families;

16 (3) the Kansas mental illness awareness council for the purposes of
17 advocacy for persons who are mentally ill and for education, research and
18 support for them and their families;

19 (4) the American diabetes association Kansas affiliate, inc. for the
20 purpose of eliminating diabetes through medical research, public education
21 focusing on disease prevention and education, patient education including
22 information on coping with diabetes, and professional education and
23 training;

24 (5) the American lung association of Kansas, inc. for the purpose of
25 eliminating all lung diseases through medical research, public education
26 including information on coping with lung diseases, professional education
27 and training related to lung disease and other related services to reduce the
28 incidence of disability and death due to lung disease;

29 (6) the Kansas chapters of the Alzheimer's disease and related
30 disorders association, inc. for the purpose of providing assistance and
31 support to persons in Kansas with Alzheimer's disease, and their families
32 and caregivers;

33 (7) the Kansas chapters of the Parkinson's disease association for the
34 purpose of eliminating Parkinson's disease through medical research and
35 public and professional education related to such disease;

36 (8) the national kidney foundation of Kansas and western Missouri
37 for the purpose of eliminating kidney disease through medical research
38 and public and private education related to such disease;

39 (9) the heartstrings community foundation for the purpose of
40 providing training, employment and activities for adults with
41 developmental disabilities;

42 (10) the cystic fibrosis foundation, heart of America chapter, for the
43 purposes of assuring the development of the means to cure and control

- 1 cystic fibrosis and improving the quality of life for those with the disease;
- 2 (11) the spina bifida association of Kansas for the purpose of
3 providing financial, educational and practical aid to families and
4 individuals with spina bifida. Such aid includes, but is not limited to,
5 funding for medical devices, counseling and medical educational
6 opportunities;
- 7 (12) the CHWC, Inc., for the purpose of rebuilding urban core
8 neighborhoods through the construction of new homes, acquiring and
9 renovating existing homes and other related activities, and promoting
10 economic development in such neighborhoods;
- 11 (13) the cross-lines cooperative council for the purpose of providing
12 social services to low income individuals and families;
- 13 (14) the dreams work, inc., for the purpose of providing young adult
14 day services to individuals with developmental disabilities and assisting
15 families in avoiding institutional or nursing home care for a
16 developmentally disabled member of their family;
- 17 (15) the KSDS, Inc., for the purpose of promoting the independence
18 and inclusion of people with disabilities as fully participating and
19 contributing members of their communities and society through the
20 training and providing of guide and service dogs to people with
21 disabilities, and providing disability education and awareness to the
22 general public;
- 23 (16) the lyme association of greater Kansas City, Inc., for the purpose
24 of providing support to persons with lyme disease and public education
25 relating to the prevention, treatment and cure of lyme disease;
- 26 (17) the dream factory, inc., for the purpose of granting the dreams of
27 children with critical and chronic illnesses;
- 28 (18) the Ottawa Suzuki strings, inc., for the purpose of providing
29 students and families with education and resources necessary to enable
30 each child to develop fine character and musical ability to the fullest
31 potential;
- 32 (19) the international association of lions clubs for the purpose of
33 creating and fostering a spirit of understanding among all people for
34 humanitarian needs by providing voluntary services through community
35 involvement and international cooperation;
- 36 (20) the Johnson county young matrons, inc., for the purpose of
37 promoting a positive future for members of the community through
38 volunteerism, financial support and education through the efforts of an all
39 volunteer organization;
- 40 (21) the American cancer society, inc., for the purpose of eliminating
41 cancer as a major health problem by preventing cancer, saving lives and
42 diminishing suffering from cancer, through research, education, advocacy
43 and service;

1 (22) the community services of Shawnee, inc., for the purpose of
2 providing food and clothing to those in need;

3 (23) the angel babies association, for the purpose of providing
4 assistance, support and items of necessity to teenage mothers and their
5 babies; and

6 (24) the Kansas fairgrounds foundation for the purpose of the
7 preservation, renovation and beautification of the Kansas state fairgrounds;

8 (ww) all sales of tangible personal property purchased by the habitat
9 for humanity for the exclusive use of being incorporated within a housing
10 project constructed by such organization;

11 (xx) all sales of tangible personal property and services purchased by
12 a nonprofit zoo which is exempt from federal income taxation pursuant to
13 section 501(c)(3) of the federal internal revenue code of 1986, or on behalf
14 of such zoo by an entity itself exempt from federal income taxation
15 pursuant to section 501(c)(3) of the federal internal revenue code of 1986
16 contracted with to operate such zoo and all sales of tangible personal
17 property or services purchased by a contractor for the purpose of
18 constructing, equipping, reconstructing, maintaining, repairing, enlarging,
19 furnishing or remodeling facilities for any nonprofit zoo which would be
20 exempt from taxation under the provisions of this section if purchased
21 directly by such nonprofit zoo or the entity operating such zoo. Nothing in
22 this subsection shall be deemed to exempt the purchase of any construction
23 machinery, equipment or tools used in the constructing, equipping,
24 reconstructing, maintaining, repairing, enlarging, furnishing or remodeling
25 facilities for any nonprofit zoo. When any nonprofit zoo shall contract for
26 the purpose of constructing, equipping, reconstructing, maintaining,
27 repairing, enlarging, furnishing or remodeling facilities, it shall obtain
28 from the state and furnish to the contractor an exemption certificate for the
29 project involved, and the contractor may purchase materials for
30 incorporation in such project. The contractor shall furnish the number of
31 such certificate to all suppliers from whom such purchases are made, and
32 such suppliers shall execute invoices covering the same bearing the
33 number of such certificate. Upon completion of the project the contractor
34 shall furnish to the nonprofit zoo concerned a sworn statement, on a form
35 to be provided by the director of taxation, that all purchases so made were
36 entitled to exemption under this subsection. All invoices shall be held by
37 the contractor for a period of five years and shall be subject to audit by the
38 director of taxation. If any materials purchased under such a certificate are
39 found not to have been incorporated in the building or other project or not
40 to have been returned for credit or the sales or compensating tax otherwise
41 imposed upon such materials which will not be so incorporated in the
42 building or other project reported and paid by such contractor to the
43 director of taxation not later than the 20th day of the month following the

1 close of the month in which it shall be determined that such materials will
2 not be used for the purpose for which such certificate was issued, the
3 nonprofit zoo concerned shall be liable for tax on all materials purchased
4 for the project, and upon payment thereof it may recover the same from
5 the contractor together with reasonable attorney fees. Any contractor or
6 any agent, employee or subcontractor thereof, who shall use or otherwise
7 dispose of any materials purchased under such a certificate for any purpose
8 other than that for which such a certificate is issued without the payment
9 of the sales or compensating tax otherwise imposed upon such materials,
10 shall be guilty of a misdemeanor and, upon conviction therefor, shall be
11 subject to the penalties provided for in K.S.A. 79-3615(h), and
12 amendments thereto;

13 (yy) all sales of tangible personal property and services purchased by
14 a parent-teacher association or organization, and all sales of tangible
15 personal property by or on behalf of such association or organization;

16 (zz) all sales of machinery and equipment purchased by over-the-air,
17 free access radio or television station which is used directly and primarily
18 for the purpose of producing a broadcast signal or is such that the failure
19 of the machinery or equipment to operate would cause broadcasting to
20 cease. For purposes of this subsection, machinery and equipment shall
21 include, but not be limited to, that required by rules and regulations of the
22 federal communications commission, and all sales of electricity which are
23 essential or necessary for the purpose of producing a broadcast signal or is
