motion to amend failed on a voice vote.

<u>Senator Francisco moved to amend the bill by using money from the job creation program rather than reducing school budgets by .05%. Senator Kelly seconded the motion. The motion failed on a voice vote.</u>

Senator Melcher moved to pass **SB1** out of committee favorably with the second by Senator Arpke. The motion carried on a roll call vote and the bill was passed out of committee.
