## Testimony of Samantha Black In support of House Bill 2500 February, 2018

Good afternoon Chairman Johnson and members of the House Taxation Committee.

I come before you today to testify in support of House Bill 2500 which would give 501c3 status to the Friends of Hospice of Jefferson County, a group of volunteers working with hospice clients and a hospice agency.

The monies raised by Friends of Hospice of Jefferson County are used to benefit the clients we serve. These monies are used to purchase care supplies (Depends, chux, gloves, disposable wipes, mouth swabs, barrier creams and lotions, nutritional supplements such as Boost, etc.), educational materials designed to reduce fear and optimize coping as well as coverage for other charges for medication and care. Providing these benefits is a multi-prong approach to not only providing physical and emotional comfort to our clients and their families but also providing this in a home setting much of the time. If we are able to keep clients in their home or the home of a loved one it is less taxing on the state aid system Kancare as we avoid unnecessary end of life facility placement.

These monies help families because when someone you love is dying your time should be focused on them rather than worrying about the insurance coverage of their care. This last August we took care of a young man in his early twenties who was insured with Kancare who had a very large spendown amount, \$1,069.37, which had not been met yet. It was only through this support of our volunteers that we were able to cover this expense so that his parents would not have to worry about this while he was dying.
