Chairman Johnson and members of the Committee, thank you for the opportunity to provide written testimony in opposition of HB 2740, proposing to increase the statewide property tax levy for schools. I am writing on behalf of Labette County Farm Bureau. Our county organization has roughly 450 members throughout our county who are active in farming and ranching.

Labette County Farm Bureau does not favor an increase in property taxes to fund schools. An income or sales tax would be a fairer option as people would pay more based upon their income capability. This is a time of low commodity prices that has many ag producers struggling to survive. They do not need an added property tax burden.

A Labette County Farm Bureau member recently shared that his property taxes have increased 40% over a four year period. In checking we have learned that ag land values may continue to increase for another year or two. Even if the mill levy stays the same, higher valuation results in an increase in taxes during this time of low market prices.

Just a little over two years ago, a rural school district serving a large part of our county proposed a bond issue for building improvements. It was defeated as property owners did not want property taxes increased.

According to the 2017 Real and Personal Property Value and Tax Summary for Labette County, 26.44% of our tax dollars goes to local school districts, 18.9% to the community college, and 32.98% for county government. This shows a large amount of property tax dollars are already funding education and local government.

Kansas Farm Bureau policy states, "The legislature should develop school finance legislation that minimizes reliance on the property tax for support of public elementary and secondary schools." And, "We favor reduction of the state property tax levy that is now part of the school finance law."

HB 2740 calls for almost doubling the required ad valorem property tax levy within a three year time frame. This comes at a time in agriculture when we are losing money in our operations and are trying to find ways to survive.

Having been members of the Kansas Farm Management Association for many years, I always enjoy the year end analysis that they provide to their membership. The 2016 average Net Farm Income for my area – the Northwest Kansas Association was only \$389. In 2015, we lost on average in my NW Kansas area \$<2,971>. I recently visited with my economist, Mark Wood, and he stated that 2017 is not looking very good either. Three years in a row of a depressed farm economy. Yet HB 2740 is proposing a tax increase to ag land owners.

I recently looked at Sherman County's 2016 Real and Personal Property Value and Tax Summary. Not surprising at all, but Ag Land contributes 33.8% of the total revenue generated and by far the largest sector. Residential homeowners came in second place with 25.55% of revenue.

In closing, we believe everyone should share in paying taxes and believe in the three-footed stool principle. Taxes should come from income, sales and property taxes. Putting more required tax on property is an unfair burden and it would make our chances of surviving in our agriculture business very unlikely.

We ask you to oppose HB 2740.






