1 AN ACT concerning school districts; creating the legislative task force on  
2 dyslexia.

3  
4 *Be it enacted by the Legislature of the State of Kansas:*

5 Section 1. (a) There is hereby established the legislative task force on  
6 dyslexia. The task force shall advise and make recommendations to the  
7 governor, the legislature and the state board of education regarding matters  
8 concerning the use of evidence-based practices for students with dyslexia.  
9 The work of the task force should be completed by November 1, 2018, and  
10 a report prepared and submitted to the governor, the legislature and the  
11 state board of education by December 1, 2018.

12 (b) The recommendations and resource materials shall:

13 (1) Research and recommend evidence-based reading practices to  
14 address dyslexia or characteristics of dyslexia for use by schools;  
15 (2) research and recommend high quality pre-service and in-service  
16 professional development activities to address reading difficulties like  
17 dyslexia, including identification of dyslexia and effective reading  
18 interventions to be used in schools and within degree programs, such as  
19 education, reading, special education, speech-language pathology and  
20 psychology;

21 (3) study and examine current state and federal laws and rules and  
22 regulations, and the implementation of such laws and rules and regulations  
23 that affect students with dyslexia; and

24 (4) identify valid and reliable screening and evaluation assessments  
25 and protocols that can be used and the appropriate personnel to administer  
26 such assessments in order to identify children with reading difficulties,  
27 such as dyslexia or the characteristics of dyslexia as part of an ongoing  
28 reading progress monitoring system, multi-tiered system of supports and  
29 child find special education eligibility for students.

30 (c) The task force shall consist of ~~17~~ **17** members as follows:

31 ~~(1) Two {Three} members of the senate with one member appointed~~  
32 ~~by the president of the senate, {one member appointed by the majority~~  
33 ~~leader of the senate} and one member appointed by the minority leader of~~  
34 ~~the senate;~~

35 ~~(2) two {three} members of the house of representatives with one~~  
36 ~~member appointed by the speaker of the house of representatives, {one~~

1 ~~member appointed by the majority leader of the house of~~  
 2 ~~representatives} and one member appointed by the minority leader of the~~  
 3 ~~house of representatives;~~  
 4 ~~(3) two members appointed by the state board of education;~~  
 5 ~~(4) one member shall be a professor employed by a state educational~~  
 6 ~~institution with specialized expertise in effective evidence-based reading~~  
 7 ~~practices for dyslexia {appointed by the president of the state board of~~  
 8 ~~regents};~~

9 ~~(5) two members shall be principals of a public school appointed by~~  
 10 ~~the united school administrators of Kansas;~~  
 11 ~~(6) four members shall be the parents of children with a diagnosis of~~  
 12 ~~dyslexia appointed by keys for networking, inc., families together, inc. and~~  
 13 ~~decoding dyslexia Johnson county;~~  
 14 ~~(7) one member shall be appointed by the Kansas association of~~  
 15 ~~special education administrators;~~  
 16 ~~(8) one member shall be a building level reading specialist appointed~~  
 17 ~~by the commissioner of education;~~  
 18 ~~(9) one member shall be a licensed psychologist or speech-language~~  
 19 ~~pathologist who diagnoses dyslexia as a part of such person's practice~~  
 20 ~~{appointed by the chairperson of the task force}; and~~  
 21 ~~(10) one member shall be identified as a nonprofit service provider~~  
 22 ~~for children diagnosed with dyslexia {appointed by the chairperson of~~  
 23 ~~the task force};~~

24 ~~(d) The state board of education shall designate one of the members~~  
 25 ~~appointed by the state board as the chairperson of the legislative task force~~  
 26 ~~on dyslexia. The chairperson shall call an organizational meeting of the~~  
 27 ~~task force on or before July 15, 2018. At such organizational meeting, the~~  
 28 ~~members will select a vice-chairperson from the membership of the task~~  
 29 ~~force. The task force also shall consider dates for future meetings, the~~  
 30 ~~agenda for such meetings and the need for electing a facilitator to assist in~~  
 31 ~~discussions among the members of the task force. The task force shall~~  
 32 ~~meet no more than six times in 2018 and may hold meetings by telephone~~  
 33 ~~or video conference, if necessary.~~

34 ~~(e) The task force may meet at any time and at any place within the~~  
 35 ~~state on the call of the chairperson. A quorum of the task force shall be~~  
 36 ~~nine members. All actions of the task force shall be by motion adopted by~~  
 37 ~~a majority of those members present when there is a quorum.~~

38 ~~(f) If approved by the legislative coordinating council, members of~~  
 39 ~~the task force attending meetings authorized by the task force shall be paid~~  
 40 ~~amounts for expenses, mileage and subsistence as provided in K.S.A. 75-~~  
 41 ~~3223(e), and amendments thereto.~~

42 ~~Sec. 2. This act shall take effect and be in force from and after its~~  
 43 ~~publication in the statute book.~~

(1) One member of the senate appointed by the chairperson of the senate committee on education;  
 (2) one member of the house of representatives appointed by the chairperson of the house committee on education;  
 (3) one member appointed by the state board of education, to serve as the chairperson of the task force;  
 (4) one member shall be a professor employed by a state educational institution with specialized expertise in effective evidence-based reading practices for dyslexia appointed by the president of the state board of regents;  
 (5) two members shall be principals of a public school appointed by the united school administrators of Kansas;  
 (6) four members shall be the parents of children with a diagnosis of dyslexia with one appointed by keys for networking, inc., one appointed by families together, inc., one appointed by decoding dyslexia Johnson county and one appointed by the international dyslexia association Kansas Missouri branch;  
 (7) one member shall be appointed by the Kansas association of special education administrators;  
 (8) one member shall be an elementary school building-level reading specialist appointed by the state board of education;  
 (9) one member shall be an elementary school special education teacher appointed by the state board of education;  
 (10) one member shall be an elementary school classroom teacher appointed by the Kansas national education association;  
 (11) one member shall be a middle school classroom teacher appointed by the Kansas national education association;  
 (12) one member shall be a licensed psychologist or speech-language pathologist who diagnoses dyslexia as a part of such person's practice appointed by the chairperson of the task force;  
 (13) one member shall be appointed by the disability rights center of Kansas; and  
 (14) the following ex-officio members, who shall be non-voting members of the task force:  
 (A) One member shall be a licensed attorney from the Kansas state department of education appointed by the Kansas state department of education; and  
 (B) one member shall be a licensed attorney who is familiar with dyslexia issues appointed jointly by the chairperson of the senate committee on education and the chairperson of the house committee on education.
