Madam Chairperson and members of the committee, good morning. My name David Shost, and I am representing the Kansas State Association of Fire Chiefs. I am offering testimony as a proponent of SB 186.

This bill would provide the framework and enabling legislation for the establishment of a supplemental reimbursement program for eligible agencies that provide Ground Emergency Medical Transportation (GEMT). This supplemental reimbursement would offset the currently minimal reimbursement rates paid by the Kansas Medicaid Assistance Program when a patient is treated and transported by ambulance.

This enabling legislation and subsequent State Plan Amendment (SPA) would provide relief at the local level to eligible EMS Agencies and Fire Departments who voluntarily elect to participate.

There is no cost to the State of Kansas. Actually, the State of Kansas (KDHE) stands to receive up to 20% of the total supplemental reimbursement for administering this GEMT Program. This could be upwards of \$4,000,000 annually based on a potential \$20,000,000 - \$22,000,000 Program for the State of Kansas.

In the State of Kansas, about 20% of an EMS provider's total transports involve patients with Medicaid coverage. This equates to about 33,000-35,000 annual Medicaid transports statewide.

At the local level, our costs of providing ambulance transport services average \$1,472 per transport. EMS Agencies and Fire Departments stand to be eligible for additional supplemental reimbursement of approximately \$628 per transport. This is in addition to the reimbursement we already receive from the Kansas Medicaid Assistance Program at an average rate of \$350/transport. \$628 multiplied by the number of Medicaid transports for an eligible EMS Agency or Fire Department spells relief.

This helps to partially but not completely cover the uncompensated costs, as we are obligated to provide life-saving EMS services to this vulnerable population within the State of Kansas.

I urge you to consider the benefits of SB 186 that would allow for all viable possibilities, as allowed by Federal Law, in the establishment of a GEMT Program in the State of Kansas. Thank you and I am pleased to stand for questions at the appropriate time.
