HOUSE OF REPRESENTATIVES

MR. CHAIRMAN:

I move to amend **Substitute for HB 2365**, on page 11, following line 8, by inserting:

"(b) During the fiscal year ending June 30, 2019, in addition to the other purposes for which expenditures may be made by the above agency from moneys appropriated from the state general fund or from any special revenue fund or funds for fiscal year 2019 for such agency as authorized by chapter 104 of the 2017 Session Laws of Kansas, this or other appropriation act of the 2018 regular session of the legislature, expenditures shall be made by the above agency from such moneys for audio broadcasts beginning on January 1, 2019, to be made of all legislative committee meetings that convene in the capitol and that are required to be open to the public pursuant to K.S.A. 75-4317 et seq., and amendments thereto, including the proceedings of the house of representatives and the senate. Such broadcasts shall be made available in real time for public access on the internet. For the purposes of this proviso, committee is defined as any standing committee, subcommittee, conference committee, interim committee or any committee that is established by law or by the presiding officer of either legislative chamber: *Provided*, That the legislative chief information technology officer shall equip all committee rooms in the capitol and the legislative chambers with audio broadcasting equipment sufficient to effectuate the provisions of this subsection. The legislative chief information technology officer shall provide for the operation and maintenance of all such broadcasting devices in a manner sufficient to provide the public with access to all committee meetings held in the capitol and the proceedings of the legislative chambers. The legislative chief information technology officer shall implement the provisions of this proviso using the same amount of moneys appropriated for such audio broadcasts for the fiscal year ending June 30, 2018: *Provided further*, That the house of representatives,

the senate and each committee may suspend the broadcasting requirements of this subsection by an affirmative vote of a majority of the members when there is an equipment failure and the purpose is not to avoid the requirements of this subsection: *And provided further*, That all broadcasts of legislative proceedings described in this subsection shall be made available in real time to the public and be accessible, along with archives of all such broadcasts, on the internet for the duration of the legislative biennium in which such broadcasts were recorded.

LEGISLATIVE COORDINATING COUNCIL

(a) During the fiscal year ending June 30, 2020, in addition to the other purposes for which expenditures may be made by the above agency from moneys appropriated from the state general fund or from any special revenue fund or funds for fiscal year 2020 for such agency as authorized by chapter 104 of the 2017 Session Laws of Kansas, this or other appropriation act of the 2018 regular session of the legislature, expenditures shall be made by the above agency from such moneys for video broadcasts beginning on January 1, 2019, to be made of all legislative committee meetings that convene in the capitol and that are required to be open to the public pursuant to K.S.A. 75-4317 et seq., and amendments thereto, including the proceedings of the house of representatives and the senate. Such broadcasts shall be made available in real time for public access on the internet. For the purposes of this proviso, committee is defined as any standing committee, subcommittee, conference committee, interim committee or any committee that is established by law or by the presiding officer of either legislative chamber: *Provided*, That the legislative chief information technology officer shall equip all committee rooms in the capitol and the legislative chambers with audio and video broadcasting equipment sufficient to effectuate the provisions of this subsection. The legislative chief information technology officer shall provide for the operation and maintenance of all such broadcasting devices in a manner sufficient to provide the public with access to all committee meetings held in the capitol and

the proceedings of the legislative chambers. The legislative chief information technology officer shall implement the provisions of this proviso using the same amount of moneys appropriated for such audio and video broadcasts for the fiscal year ending June 30, 2018: *Provided further*, That the house of representatives, the senate and each committee may suspend the broadcasting requirements of this subsection by an affirmative vote of a majority of the members when there is an equipment failure and the purpose is not to avoid the requirements of this subsection: *And provided further*, That all broadcasts of legislative proceedings described in this subsection shall be made available in real time to the public and be accessible, along with archives of all such broadcasts, on the internet for the duration of the legislative biennium in which such broadcasts were recorded: *And provided further*, That on or before January 15, 2020, the legislative chief information technology officer shall submit a report to the legislature on the accessibility of legislative proceedings to the public. Such report shall include the volume of traffic on the legislative website and the number of times audio and video broadcasts were accessed during the preceding year.";
