SUBJECT: Fiscal Note for HB 2662 by House Committee on Health and Human Services

In accordance with KSA 75-3715a, the following fiscal note concerning HB 2662 is respectfully submitted to your committee.

HB 2662 would amend existing law to increase the legal maximum license fees for the Kansas Board of Barbering. The current and proposed maximum fees are as follows:

Page 2—HB 2662

The Kansas Board of Barbering indicates that enactment of HB 2662 would allow the agency to implement a 12.0 percent across-the-board increase in fees beginning in January 2019. This would result in increased revenue in FY 2019 of \$8,175 and approximately \$17,000 annually for each year following. The agency plans to use revenues from the increased fees for updated technology and a new vehicle and would determine every three years following the initial increase whether fees should be increased again. Any fiscal effect associated with HB 2662 is not reflected in *The FY 2019 Governor's Budget Report*.
