SUBJECT: Fiscal Note for SB 350 by Senator Hawk, et al.

In accordance with KSA 75-3715a, the following fiscal note concerning SB 350 is respectfully submitted to your committee.

SB 350 would require that every committee bill or resolution be requested for introduction by a member of the Kansas Senate or Kansas House of Representatives. For any bill approved for introduction and sponsored by any standing committee of either house of the Legislature, the committee chairperson would be required to keep or have the committee secretary keep minutes of meetings that include the member that requested the bill for introduction by the committee.

For any bill sponsored by any standing committee of either house of the Legislature, in addition to the sponsor of the bill, the printed version of the bill would include the member that requested the bill for introduction by the committee. When a substitute bill is recommended by a committee or the committee recommends amendments to a bill that strike all of the material in the bill subsequent to the enacting clause and that insert new material, the printed version of the bill would provide the committee recommending the substitute bill or amendments as the sponsor of the bill, replacing the original sponsor. In addition, any member required to be included on the printed version of the introduced bill as required by SB 350 would be removed.

Page 2—SB 350

According to Legislative Administrative Service, enactment of SB 350 would require additional FY 2019 expenditures totaling \$49,900, all from the State General Fund, as programming changes to the Kansas Legislative Information System and Services would be required. The agency would perform extensive testing of the modifications to ensure the entire bill process, from bill drafting to statute update and publication, function properly. Any fiscal effect associated with SB 350 is not reflected in *The FY 2019 Governor's Budget Report*.
