1 AN ACT ***concerning roads and highways***; designating a portion of United
2 States highway 75 as the ~~SGF~~ Eldon K Miller memorial highway ***and a***
3 ***portion of interstate 70 as the John Carlin highway***; amending K.S.A.
4 2016 Supp. ***68-1009 and*** 68-1051 and repealing the existing ~~section~~
5 ***sections***.

7 *Be it enacted by the Legislature of the State of Kansas:*

8 New Section 1. The portion of United States highway 75 from the
9 northern border of Woodson county, then south on United States highway
10 75 to the northern city limits of the city of Yates Center is hereby
11 designated as the ~~SGF~~ Eldon K Miller memorial highway. Upon
12 compliance with K.S.A. 2016 Supp. 68-10,114, and amendments thereto,
13 the secretary of transportation shall place highway signs along the
14 highway right-of-way at proper intervals to indicate that the highway is the
15 ~~SGF~~ Eldon K Miller memorial highway.

16 Sec. 2. K.S.A. 2016 Supp. 68-1051 is hereby amended to read as
17 follows: 68-1051. The portion of United States highway 75 where it enters
18 the state on the Kansas-Nebraska border on the north then south to the
19 junction with K-9, then south from the junction of K-9 with K-62 to the
20 junction of K-62 with K-16 then east to the junction with United States
21 highway 75 then south on United States highway 75 to the southern city
22 limits of Holton, then from the junction of United States highway 75 and
23 N.W. 46th street in Shawnee county then south on United States highway
24 75 to the southern boundary of Osage county, then from the northern
25 ~~boundary of Woodson county~~ *city limits of the city of Yates Center* south
26 on United States highway 75 to *the* northern interchange with United
27 States highway 400, then south from the southern interchange with United
28 States highway 400 to the Kansas-Oklahoma border, is hereby designated
29 the purple heart/combat wounded veterans highway. The secretary of
30 transportation shall place markers along the highway right-of-way at
31 proper intervals to indicate that the highway is the purple heart/combat
32 wounded veterans highway. The secretary of transportation may accept
33 and administer gifts and donations to aid in obtaining suitable highway
34 signs bearing the proper approved inscription.

1 *New Sec. 3. The portion of interstate highway 70 from the junction*
2 *with highway K-15 then west to the junction with United States highway*
3 *81 is hereby designated as the John Carlin highway. Upon compliance*
4 *with K.S.A. 2016 Supp. 68-10,114, and amendments thereto, the*
5 *secretary of transportation shall place highway signs along the highway*
6 *right-of-way at proper intervals to indicate that the highway is the John*
7 *Carlin highway.*

8 *Sec. 4. K.S.A. 2016 Supp. 68-1009 is hereby amended to read as*
9 *follows: 68-1009. (a) The portion of United States highway—No. 40*
10 *traversing this state where it crosses the Missouri-Kansas border on the*
11 *east to the point where it leaves the state on the west at the Kansas-*
12 *Colorado line, be and it is hereby designated as the official east-west*
13 *Blue Star memorial highway in the state of Kansas.*

14 *(b) If the state of Missouri designates a portion of interstate*
15 *highway 70 as the Truman/Eisenhower Presidential highway, or*
16 *something substantially similar, then the portion of United States*
17 *highway—No. 40 from where it crosses the Missouri-Kansas border, to the*
18 *west city limits of Topeka, and then from the junction of highway K-15*
19 *United States highway 81 with United States highway—No. 40, then west*
20 *on United States highway—No. 40 to the point where it leaves the state at*
21 *the Kansas-Colorado line, shall be designated as the official east-west*
22 *Blue Star memorial highway in the state of Kansas.*

24 repealed.

25 ~~Sec. 4.~~ 6. This act shall take effect and be in force from and after its
26 publication in the statute book.
