1 AN ACT making and concerning appropriations for the fiscal year ending
2 June 30, 2019, for the department of corrections.

4 *Be it enacted by the Legislature of the State of Kansas:*

5 Section 1. (a) For the fiscal year ending June 30, 2019, appropriations
6 are hereby made, restrictions and limitations are hereby imposed, and
7 transfers, capital improvement projects, fees, receipts, disbursements,
8 procedures and acts incidental to the foregoing are hereby directed or
9 authorized as provided in this act.

10 (b) This act shall not be subject to the provisions of K.S.A. 75-
11 6702(a), and amendments thereto.

12 (c) The appropriations made by this act shall not be subject to the
13 provisions of K.S.A. 46-155, and amendments thereto.

36 (b) All moneys appropriated pursuant to subsection (a) shall be used

1 for the purpose of paying for salary increases, including associated
2 employer contributions, during fiscal year 2019, for uniform correctional
3 officers to rise to the same level of salary as the uniform correctional
4 officers at El Dorado correctional facility.

5 Sec. 3. *Severability.* If any provision or clause of this act or
6 application thereof to any person or circumstances is held invalid, such
7 invalidity shall not affect other provisions or applications of the act that
8 can be given effect without the invalid provision or application, and to this
9 end the provisions of this act are declared to be severable.

10 Sec. 4. *Appeals to exceed expenditure limitations.* (a) Upon written
11 application to the governor and approval of the state finance council,
12 expenditures from special revenue funds may exceed the amounts
13 specified in this act.

14 (b) This section shall not apply to the expanded lottery act revenues
15 fund, the state economic development initiatives fund, the children's
16 initiatives fund, the state water plan fund or the Kansas endowment for
17 youth fund, or to any account of any of such funds.

18 Sec. 5. This act shall take effect and be in force from and after its
19 publication in the statute book.
