To concerned legislators,

It has come to my attention that there are a handful of legislators who may be concerned about the ACIP recommendations, rightfully so. I am currently a resident of Missouri but have resided in Kansas and may do so again. As we reside in a metroplex covering two states I am compelled to address both legislative bodies.

I was raised in a medically professional family. My father was a pathologist and my mother a psychologist. I followed all ACIP recommendations for all my children up to the Gardasil HPV (Human Papilloma Virus) vaccine series my daughter had in 2008-2009. I had a cryo surgery in my early 20's that required removing offensive tissues in my cervix from HPV. When the Gardasil series came out there was a huge campaign and I was determined my daughter would not have to experience what I did. I enrolled her for the series.
