Dear Education Committee,

Here is my testimony:

God's ways are perfect, and many times, His plans begin years before the appointed time of completion. This is the case with my family and our experiences with vaccines. Years ago, when my oldest son, Jerome, was still in college, he began researching vaccines. At that time, he just found the subject interesting, but since then, God has revealed much to him, to all of us, through countless hours of research and through prayer. Little did we know that we would need this knowledge to deal with vaccine injury in our own family.

In the Spring of 2017, my youngest son, Roy, a gifted musician (pianist, violinist, trombonist) who was attending the University of Kansas, called to report that he was having serious symptoms that sent him to the E.R. An MRI report, serious enough for us to travel to Lawrence, was the result. As my husband and I, along with Roy, stared at the MRI while the neurosurgeon pointed to lesion after lesion on Roy's brain, we were told that he would need to immediately begin treatment for M.S. and that he would have to be on medication for the rest of his life.

But the beginning of this journey goes back even further. In Roy's senior year of high school, his school sent us a letter stating that he would need to receive a tetanus shot or he would not be given his diploma. Besides our moral objection to vaccinations due to the aborted fetal cell lines some still contain (There are still many that contain human DNA—there is even a set amount of DNA allowed in each vaccination.) and because our other son Paul experienced seizures for several days after being vaccinated, we objected to him receiving it. Moreover, because of all the research Jerome and I had done, I knew that a tetanus shot was not necessary for Roy's health, but the school was adamant. In the end, Roy didn't want to make a fuss so close to graduation, so he decided to give in. The only tetanus shot that was available to him was the Dtap vaccination. So, instead of being injected with one virus, he was injected with diphtheria, pertussis, tetanus, as well as a host of other toxic ingredients, including formaldehyde and aluminum. High levels of aluminum have been found in children with autism, and formaldehyde is a known carcinogen.

Immediately, Roy developed daily, severe hives on his back. From that day forward, he was forced to take Claritin or other antihistamines to keep the hives under control—every day, without fail. On occasion, his face and head would swell up, become fire-engine red, and produce a scale-like, raised skin rash for no reason. So...fast forward three years later and we are standing in the neurosurgeon's office counting lesions on Roy's 21-year-old brain. Thankfully, the Lord had been preparing me for the moment. My continued surrender and response to His middle of the night question, "Will you be My Voice?" had begun almost 20 years prior, so by then, I was familiar with the calming of His Holy Spirit, His Voice that told me not to panic, what questions to ask the doctor, and His courage that strengthened me to reject the traditional methods for treating M.S. and look to find the *cause* of this disease.

By God's blessed providence, we knew that there had been something in the vaccines that caused a severe reaction in Roy—something that was triggering his immune system to overreact—which is what M.S. is—an autoimmune disease. The Holy Spirit reminded me of what a pediatric neurosurgeon who gave a talk on vaccine injury and had said several years prior: "The vaccines are causing brain damage and symptoms that mimic other diseases like M.S." With this memory "nugget" in mind, we took Roy to a natural-path physician specializing in neurology who tested him for toxins—including aluminum and mercury, which can both be found in high concentration in vaccinations. These facts have been largely hidden to the public. Roy's levels

tested toxic for both. This doctor immediately began a series of detox treatments for mercury and aluminum. After just 4 months, Roy's MRI was repeated. The entire left side of his brain was lesion free. After the remaining year's detoxing, a third MRI showed that his entire brain was lesion free—the only remaining tiny spots were deemed to be scar tissue. He hasn't had a single symptom since he was treated. Praise GOD!

As you are probably aware, children who once received less than 25 doses in 1986, now receive more than 70 doses by the age of eighteen. Meanwhile, children have more chronic illnesses, including asthma, eczema, and allergies, including peanut allergies. Few people realize that peanut oil was used as an antigen in vaccines for a number of years—hence the explosion of kids with peanut allergies.

I wholeheartedly believe that no one should be forced to put something in their body that they have a moral objection to. I am morally opposed to the vaccines use of aborted fetal tissue. I am morally opposed to forcing the toxic ingredients they contain upon persons who would rather use good nutrition and natural or modern *medicine* and/or putting their faith in God to treat the symptoms. I am morally and civically opposed to the lack of transparency on the part of the government, the pharmaceuticals, and anyone in the medical community who would keep the potential risks hidden from patients and the public at large—much like they suppressed the truth about the birth control pill causing spontaneous abortion and increasing breast cancer and other cancers.

It has been proven from multiple government and pediatric studies, that vaccinations do NOT prevent the colonization or the transmission of a disease. In fact, in recent years, the pharmaceutical companies and CDC are admitting that persons RECENTLY VACCINATED can “shed” (spread) the viruses to the unvaccinated and immune-compromised for 6 to 8 weeks. This is listed inside the vaccine inserts, but most patients are never given these or encouraged to read them. In fact, those recently vaccinated are asked to stay away from cancer treatment centers and other immune-challenged persons. Viruses and germs are everywhere and cannot fully be eradicated. In fact, children who are vaccinated are getting the viruses they were vaccinated against, and we are experiencing mutation of viruses because of vaccinations. Kids leaving school with vaccine-induced fevers is a common occurrence. Should “medicine” cause fevers? Are we bypassing God's perfect design? YES

Vaccine risks are real—for some, the risks are lifelong. To others, they are fatal. Many doctors believe that Sudden Infant Death Syndrome is actually caused by vaccination in newborns. As far back as the 1970's vaccines were causing health issues and side effects, such as guilliam-barre syndrome. If you were to talk to generations before us about measles and chickenpox, you would likely hear that whole families visited each other to CATCH these bugs so they could get them over with. They were mostly a nuisance, yet now, they are made out to be deadly. This is widely spread propaganda and blatant deception. Just one among many misrepresentations that comes to mind, is the fear of Polio. Most do not realize that polio is spread through fecal matter, rather than a contagious, air-borne virus, and that polio numbers had drastically fallen BEFORE the vaccination was ever introduced. This was due to the discontinuation of dumping sewage into our water systems.

The absolute truth is, vaccinations do NOT provide lasting immunity, that's why so many “boosters” are being added to the schedule. In reality, the only *lasting* immunity we acquire is through our body's natural immune response to fighting a virus. And sadly, for some children, their well-visit to the pediatrician becomes the LAST TIME THEY ARE WELL.

I am sure you are aware that most vaccines were developed using aborted fetal cells. This, in itself, is an offense to our conscience. Besides wondering what the long-term and cumulative effects of having another person's DNA shot directly into our child's body, my faith teaches us that is it never ok to use an inherent evil as means to accomplish a good. There are companies now who are trying to make vaccinations without fetal

cells, but many still contain them, and we don't really know what the animal DNA they are substituting with will do to our bodies either. There are doctors who will admit that they don't see chickenpox any more, but what they ARE seeing is SHINGLES in their very young patients—as young as grade school. This is DISTURBING! It was unheard of before the chickenpox vaccination came into play. Shingles is much more painful and long-lasting than chickenpox! Most are unaware that shingles is listed as a side effect on the chickenpox vaccine insert, and many are unaware that the shingles vaccine for adults can also GIVE them shingles. When my boys were young, I distinctly remember taking them for a well-check visit and having the nurse talk me into the chickenpox vaccine. She told me that, unlike the other vaccines, there were zero side effects. Though I believe she did not lie intentionally, what she was told and shared with me, was simply not true. One woman I know who became a nurse later in life took a job at a pediatric clinic. I shared my concerns with her one day and she said to me, "If I had to do it all over again, I would never vaccinate my kids. I see too much now."

I am not against modern medicine. I believe that God has given us good things through good people in this field. What I am opposed to is the overreach of government or any entity that would force a person to act against their conscience. The CDC's list of vaccine ingredients should absolutely shock every individual, but most don't even check it out because they are so fully convinced that their child will perish without these vaccines—which is sheer deception. Vaccinations these days are like the Holy Grail to the medical community and to consumers who are filled with fear. To this day, there are doctors who don't even realize how toxic they are or that they contain human DNA. They have been taught one way, by one institution, and shown studies that make sense to their human minds, but the millions of vaccine-injured families are out there shouting a different truth than what they've been taught. No matter how many government "studies" they come up with, the parent who sees their healthy child "disappear" after their fifteen-month vaccinations, only to be later diagnosed with Autism, will tell you that they do not believe the studies for one minute. The numbers are growing. The damage is cumulative through each generation. But the truth is coming out, at long last.

I am sure that you have heard that, in recent years, the World Health Organization and Unicef were caught, by Catholic bishops, in the act of putting sterilization drugs into the vaccinations of girls in Africa. There are many wealthy, powerful individuals in this country who believe in population control, so being forced to inject ANYTHING into our bodies against our will is NOT freedom, NOT CONSTITUTIONAL, AND IT'S TYRANNY.

Along with the facts that are out there, but very rarely known or embraced, age old wisdom points to grave error in vaccinations. Vaccinations are NOT MEDICINE. Constitutionally speaking, we have a RIGHT TO LIFE, LIBERTY AND THE PURSUIT OF HAPPINESS. If the vaccines don't work--and they don't, if they are DANGEROUS TO MY BODY AND I AM MORALLY OPPOSED, I HAVE THE RIGHT TO VEHEMENTLY REJECT THEM.
