## Possible action on bills previously heard

Senator Alley moved, seconded by Senator Kerschen, to remove the contents of **HB 2118** and replace the contents with the contents of **SB 294**, as amended and passed by the Senate Committee of the Whole to create **Senate Substitute for HB 2118**. The motion carried.

<u>Chairperson Tyson moved, seconded by Senator Longbine, to give the Revisor of Statutes technical leeway to accomplish the intentions of the Committee.</u> The motion carried.

Senator Longbine referred Committee members to Proposed Bill No. \_\_ (20rs3409) providing for a delay of penalties and interest for property taxes and delaying certain associated property tax dates in 2020, only.

<u>Senator Longbine moved, seconded by Senator Petersen, to adopt the balloon amendment providing</u> for a delay of penalties and interest for property taxes from May 10, 2020 to August 10, 2020 for tax year 2019. The motion carried. (Attachment 1)

<u>Chairperson Tyson moved, seconded by Senator Braun, to adopt the balloon amendment changing the latest possible hearing date from September 15 to September 10</u>. <u>The motion carried.</u> (Attachment 4)

Senator Goddard moved, seconded by Senator Kerschen, to amend by inserting the contents of **SB 295** that passed the Senate Committee of the Whole. The motion carried.

<u>Senator Longbine moved, seconded by Senator Petersen, to pass **Senate Substitute for HB 2118** favorably as amended. The motion carried.</u>

## **HB 2466--Enacting the Taxpaper Protection Act**

Senator Kerschen referred Committee members to Proposed Senate Bill No.\_\_ (20rs3408) providing for an extension of certain income and privilege tax filing and payment deadlines in 2020, only.

Senator Kerschen moved, seconded by Senator Longbine, to adopt the balloon amendment, extending income and privilege tax filing and payment deadlines in 2020, lining up with the federal timeline amend the bill by inserting the contents of 20rs3408. The motion carried. (Attachment 5)

Senator Longbine moved, seconded by Senator Braun, to pass **HB 2466** favorably as amended. The motion carried.

Chairperson Tyson moved, seconded by Senator Braun, to remove the contents of HB 2490 and replace with the contents of SB 242, as amended by the Senate Committee on Assessment and Taxation and as passed by the Senate Committee of the Whole SB 262, SB 264, SB 265, SB 272, SB 297, and SB 309. creating Senate Substitute for HB 2490.

<u>Senator Braun moved, seconded by Senator Holland, to pass Senate Substitute for **SB 2490** favorably as amended. The motion carried.</u>

Chairperson Tyson thanked the Committee and staff for their work this legislative session.
