1 AN ACT concerning the university of Kansas medical center; relating to  
2 ~~the financing thereof; creating the cancer research and public~~  
3 ~~information trust fund~~ **cancer center research; making and**  
4 **concerning appropriations for the fiscal year ending June 30, 2021.**

6 *Be it enacted by the Legislature of the State of Kansas:*

7 Section 1. (a) There is hereby established in the state treasury the  
8 cancer research and public information trust fund, to be administered by  
9 the university of Kansas medical center. All

10 **Section 1.**

11 **UNIVERSITY OF KANSAS MEDICAL CENTER**

12 (a) *There is appropriated for the above agency from the state*  
13 *general fund for the fiscal year ending June 30, 2021, the following:*

14 **Cancer center research (683-00-1000-0700).....\$10,000,000**

15 **Provided, That any unencumbered balance in the cancer center research**  
16 **account in excess of \$100 as of June 30, 2020, is hereby reappropriated**  
17 **for fiscal year 2021: Provided further, That all moneys credited to the**  
18 **fund in the above account** shall be used to enhance research at the  
19 university of Kansas cancer center in the areas of laboratory, clinical and  
20 population-based research; and to recruit and retain cancer researchers and  
21 clinicians to conduct cancer research, education and outreach programs for  
22 Kansans. ~~And~~ **And provided further, That all** expenditures from the cancer  
23 research and public information trust fund **center research account** shall  
24 be approved by the director of the university of Kansas cancer center or  
25 the director's designee.

26 (b) ~~On July 1, 2020, and on July 1 of each year thereafter, the director~~  
27 ~~of accounts and reports shall transfer \$10,000,000 from the state general~~  
28 ~~fund to the cancer research and public information trust fund.~~

29 (e) ~~On:~~ **And provided further, That on** January 1, 2021, ~~and on~~  
30 ~~January 1 of each year thereafter,~~ the director of the university of Kansas  
31 cancer center shall submit a report to the legislature detailing the manner  
32 that such appropriated moneys are used to enhance cancer research, cancer  
33 education and outreach programs: **And provided further, That the first**  
34 **\$5,000,000 in expenditures from the cancer center research account**

1 *shall be matched by the university of Kansas medical center on a \$1-for-*  
2 *\$1 basis from other moneys of the university of Kansas medical center.*

3       Sec. 2. This act shall take effect and be in force from and after its  
4 publication in the statute book.
