Chairwoman Senator Molly Baumgardner and Members of the Joint Committee on Corrections and Juvenile Justice Oversight.

I am contacting you on behalf of the Kansas Community Corrections Association representing the statewide community corrections programs. We appreciate your committee's attention to the value and benefits of the work we provide to keep our communities safe. Our conversation with your committee on Monday raised issues regarding the funding needed for our public safety work. In response to our testimony and issues your committee raised, we would like to provide additional information.

- We concur with your staff that the funding enhancement for FY 22 and FY 23 that the Legislature and the Governor approved did not have any provisos or restrictions on their use.
- Moreover, the funding was added to the existing fund that contained all the grant dollars in the KDOC budget for community corrections grants and not set apart in a unique fund.
- We hope the committee can encourage and ensure that these additional funds are distributed to community corrections agencies according to the existing grant process and allow the existing local and state budget processes to determine the use of all the grant funds. This requirement will eliminate the limitations on the use of funds in 2022 that forced some agencies to return funds.
- We encourage the committee to suggest KDOC allow agencies to retain unexpended grant funds and suggest in FY 24 the enhancements from FY 22 and FY 23 are all distributed based on the grant formula.
- Finally, you had questions regarding our request for \$1 million in behavioral health grant funds to increase our \$3 million fund. At your suggestion we did a very quick assessment of our members' best estimates as to the actual level of behavioral health funding needs. At your request, we can provide a rough estimate of \$3.7 million in additional unfunded need for behavioral health services that includes mental health and substance use disorder treatment.

Thank you for your time and attention to this important issue. Please contact your local community corrections agency for any additional information about the work being done in your community. I am attaching a directory of the community corrections programs.

We are happy to respond to questions at the appropriate time.
