He explained that the bill is needed in order to continue operational success of legion posts across Kansas.

**Hearing on: SB137 — Expanding the military spouse and service member's expedited licensure law to all applicants who have established or intend to establish residency in Kansas, providing for licenses in an emergency declared by the legislature, allowing telemedicine by out-of-state healthcare providers and permitting the use of electronic credentials.**

Chairman Olson opened the hearing on **SB137** and called upon Charles Reimer for a Revisor of Statutes overview of the bill.

Chairman Olson called upon Representative Chris Croft for primary proponent testimony on the bill. Rep. Croft shared practical and technical history on the bill. He stated that the essence of the bill is to help build and increase the Kansas workforce.
