- T. Reed had 132 votes cast (123 Election Night + 1 accepted by BOCC + 8 from Osage County = 132 votes)

This is written request for 2021 hand recount of all votes cast in voting area: School Board USD #251, District 1, Position 4

between candidates Perry Peterson and Tammie Reed,

involving precincts 22, 23, 26, 30.

The recount by hand will include: provisional ballots, objected to ballots, void ballots, unvoted ballots, voted ballots, "spoiled ballots", advanced voting ballots, adjudicated ballots, mail-in ballots, in-person ballots, absentee ballots, all hand counted ballots, machine counted ballots, misfeed ballots, all rejected ballots, all ballots with mismarked races, all ballots with wrinkles, all ballots voted in pencil or other means that election machine did not pick up, all double voted races, all duplicate ballots, all paper ballots.

The 2021 hand recount of School Board USD #251, District 1, Position 4 has a bond set by Tammy Vopat, Lyon County Election Clerk, on 11/9/21, for the amount of \$250.00 to be submitted with written request and presented as check, cash, or money order. The bond will be held as security until final recount is tabulated by a bi-partisan special election board selected by Tammy Vopat. If USD #251 District 1, Position 4 tabulation remains the same as it was prior to recount, the \$250.00 bond will be used to pay the special election board. If hand recount of USD #251 District 1, Position 4 results in change of School Board race winner, Lyon County will pay the special election board wages and return the \$250.00 bond to the requestor.
