It reunites the Shawnee Mission District in SBOE-2. It reunites western Kansas in SBOE-5. It reunites the SBOE-6 in NE Kansas. It keeps the proposed Apple map for SBOE-3 including the Blue Valley and Olathe school districts together.

I would appreciate it if this was proposed formally, reviewed, and considered. It takes the best elements of previous maps introduced and keeps the current SBOE districts statewide as unchanged as possible following committee guidelines.

SBOE 2 = 7, 8, 10, 21  
SBOE 3 = 11, 23, 35, 37  
SBOE 4 = 2, 18, 19, 20  
SBOE 5 = 33, 38, 39, 40  
SBOE 6 = 1, 22, 24, 36  
SBOE 7 = 17, 14, 31, 34  
SBOE 8 = 25, 28, 29, 30  
SBOE 9 = 3, 12, 13, 15  
SBOE 10 = 16, 32, 26, 27
