Chairman and Members of the Committee:

The State of Kansas has spent years trying to destroy an innocent person's dream car because of alleged VIN issues.¹

CIVIL ASSET FORFEITURE

Although the State of Kansas Admits This Guy Is Innocent, It Still Wants To Destroy His 1959 Corvette

Richard Martinez lost his dream car because of VIN-plate issues prosecutors admit he was "not aware of."

Kansas Justice Institute² filed an *amicus* brief³ in the ongoing case arguing, among other things, that the government has a legitimate interest in deterring vehicle fraud, but not at the expense of those who have been defrauded; and certainly not at the expense of those the government believes are—beyond question—innocent. The government has police powers sure enough, but it cannot wield those powers oppressively, unfairly, or arbitrarily, nor allow its agents to do the same—to do so violates due process of law.

The United States and Kansas Constitutions do not permit the government to acknowledge a person's innocence, on the one hand, and then with the other, declare the innocent person's property "contraband" and take it. If that were the standard, there would be few limits on the government's ability to seize and destroy nearly anything it so desired.

Innocence matters—the government should not get to destroy a person's car for a wrong they did not commit. That is unconstitutional.
